

## मक डिसपोजल सम्बन्धी प्रमाण पत्र

जनपद-मथुरा में गेल गैस लिमिटेड द्वारा सिटी गैस डिस्ट्रीब्यूशन परियोजना के अन्तर्गत छाता-कोसी, कोसी-नन्दगांव रोड़ औद्योगिक क्षेत्र, सिहाना-वृन्दावन, छटीकरा-गोवर्धन, रिफाइनरी-बी०पी०सी०एल आउटलेट (यू०पी०एस० आई०डी०सी० औद्योगिक क्षेत्र) तथा राष्ट्रीय राजमार्ग संख्या-2 एवं अन्य मार्गों के किनारे 8"/6"/4" की व्यास की पाइप लाइन बिछाने के कार्य में जिसमें प्रभावित होने वाली 3.8463 है० संरक्षित वन भूमि प्रभावित होगी। उक्त आरक्षित वनभूमि में खुदान कार्य के पश्चात् उससे उत्पन्न अवयवों/कूड़ा-कर्कट हेतु मक डिस्पोजल प्लान का विवरण निम्न प्रकार है :-

### Disposal/Management plant

While preparing FCA case, if there is any activity in the project which involves digging of land, much disposal/management plan has to be prepared.

#### Should include:-

1. Calculation of muck to be generated. Self factor has to be applied. N.A.
2. Quantity of muck to be utilized in the project activities. N.A.
3. Balance quantity of muck, which requires disposal/management plan. N.A.
4. Carriage of muck from the much generation site in the dumping site. N.A.
5. Ownership of land and the consent of land owner, in case muck disposal on non forest land. N.A.
6. Photograph & carrying capacity of proposed dumping site (muck disposal site) N.A.
7. Development of dumping site-construction of retaining walls and other structure as per requirement of the site. The objective is to completely stop rolling down of the muck. N.A.
8. Rehabilitation of dumping site like leveling, planting of grass, shrubs and tree species-

#### After laying of gas pipeline being done.

Cost to be incurred on the above activities has to be given component wise. Detail of dumping site including length, width and height of structures to be exacted must be mentioned.

Undertaking by the user agency has to be given to the effect that


1. Muck management plan will be implemented by the user agency and in case of non implementation of the plan; they will be liable to penalty/action at their cost.
2. The proposed dumping site is located away from river/stream/nala.
