Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons;	The proposal is recommended as the user agency has agreed to reduce the area, which has reduced the No of trees to be felled from 72 to 34 . For developmental needs of the area this minimum diversion is required. The area to be diverted has been reduced from 0.3534 ha to 0.1820 ha. The loss caused to forest area has thus been minimized balancing the twin needs of development and conservation and thus the proposal is recommended for approval.
