

## PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub: Administrative approval for Belur-Hassan Railway Line instead of Belur -Sakaleshpur Line in Chikkamagaluru-Belur-Sakaleshpura new Railway Line Project.

### Preamble:

Government of Karnataka vide its G.O read at Sl. No (1) above, accorded administrative approval for 47 kms Chikkamagalur-Belur-Sakaleshpura new Railway Line Project at an estimated cost of Rs.657.80 crore on 50:50 cost sharing basis between Government of Karnataka and Ministry of Railways and to provide the required land free of cost to South Western Railways.

2. During the review meeting of Railway projects held under the Chairmanship of Hon'ble Chief Minister read at Sl. No. (2) above, it was observed that while the land acquisition and construction cost is more, there would be fewer commuters in the Belur- Sakaleshpura Railway lines section when compared with land acquisition and construction cost for Belur- Hassan. Therefore it was decided to seek an estimate from the Railways to take up the Belur- Hassan stretch instead of Belur- Sakaleshpura line.

3. Government of Karnataka in its letter read at Sl. No. (3) above, sought a detailed estimate from Railways in order to take up construction of New Railway line between Belur- Hassan on 50:50 cost sharing basis.

4. Chief Engineer Construction (East) South Western Railways Bengaluru in the letter read at Sl. No (4) above submitted the comparative statement of the estimated cost for the Belur- Sakaleshpura Railway line and Belur- Hassan Railway Line Project, the details are has given below

5. The proposal of South Western Railways has been examined in detail and hence this order.

**GOVERNMENT ORDER NO: IDD 95 NSW 2018,**

In the circumstances explained in the preamble, after careful examination of the proposal, Government of Karnataka hereby accords administrative approval for the following;

- i. *Dropping the Belur-Sakaleshpura Railway line stretch in the Chikkamagaluru-Belur- Sakleshpura Railway Line and to take up Belur – Hassan New Railway Line at an estimated cost of Rs.462.08 crores*
- ii. *Providing land free of cost for this project to Railways and to take up the project on ratio of 50:50 on cost sharing basis with the condition that the project be completed within 3 years."*
