So a fresh KML file showing the area against each segment of the proposed area to be uploaded and be send by email to the Nodal Officer (FC Act), Assam for ascertaining the exact proposed forest area to be use for nonforestry purpose.	Done, a new KML file is uploaded showing the area against each segment of the proposed area and the same is also sent by email to the Nodal Officer
3.	C-(iii) –The uploaded scan copy of 1:50,000 scale SOI toposheet map has reflected 16.772 ha area against each of the 3 nos of different segment totaling 50.316 ha of propose area under Doyang RF. But as per the information reflected in the uploaded legend of the map, the total area proposed to be diversion under Doyang RF segment is 16.772 ha area. So clarify the disparity and upload.
