



## TO WHOMSOEVER IT, MAY CONCERN

In compliance of the Rule 6(3)(e) of the Forest (Conservation) Rules, 2003 [as amended vide the Forest (Conservation) Amendment Rules 2014; Forest (conservation) second Amendment Rules 2014 and Forest (Conservation) Amendment Rules 2016] it is certified that 1.586ha. of forest land proposed to be diverted in favour of Project Implementation Unit, National highways Authority of India for development of 4/6 Lane Ayodhya Bypass of 67.572 kms (Package 1 Northern Ayodhya Bypass starting at km 112+540, ending at km 139+928 and package 2 Southern Ayodhya Bypass starting at km 112+540, ending at km 153+281 of NH-28 ) under NHDP Phase-VII in Ayodhya in the state of Uttarpradesh having no recorded population of scheduled Tribes as per census of India 2001 and 2011. It is further certified that:

- (a) The Protected Forest namely Faizabad-Akabarpur Road, Faizabad-Akabarpur Railway Line, Faizabad-Sultanpur-Allahabad Road, Faizabad-Sultanpur-Allahabad Railway Line, Faizabad-Raebareli Road, Lucknow-Faizabad Railway Line and Lucknow-Faizabad Road involved in the above villages are plantations raised on non-forest land on or after 13<sup>th</sup> December 1930 and were notified as PF vide notification nos-1115/14-331-50 dated 10-Feb-1960, 104(2)/14-2-503-77 dated 29-may-1977, 3208/14 dated 23-Aug-1955, 3559/चौदह-503-77 dated 22-June-1978, 1115/14-331-50 dated 10-Feb-1960, 104(2)/14-2-503-77 dated 29-may-1977, 3208/14 dated 23-Aug-1955 respectively.
- (b) Therefore, these PFs neither have residing Scheduled Tribes nor have Other Traditional Forest Dwellers (residing in the PFs for more than 75 years) having rights recognized under Forest Rights Act, 2006.
