If required, provided the VLC proceedings for other villages also. | The Toks to be benefited i.e. Syal Dobha, Khaliyon, Khali, Khamoli are under revenue village Maniguh . Mr Manoj Singh is Gram Pradhan for all these villages/Tok. Hence VLC level proceeding is provided for Maniguh only. |
