Proposal for NOC for access permission to Retail Outlet M/s HPCL at Km. 169.999 (LHS) on NH-15(new NH 54) at village Talwandi Nepala, Tehsil Zira & District Ferozepur, in the State of Punjab.

Sir,

This is in reference to your memo no. 2225/NH dated 30.06.2020, submitting therewith subject proposal for consideration of this office. Based on your recommendations, the proposal for access to the subject Retail Outlet, by extending 7m wide & 742m long service road, and merging it with proposed access of another Provisionally approved BPCL retail outlet (near chainage 169.408 km) has been accepted provisionally by Highway Administration (HA) subject to the following conditions:-

That the Oil Company will construct the fuel station along with its access as per (i) approved drawings at their own cost within 6 months of issue of provisional NOC. In case, the construction is not done in one year, the provisional approval shall be

deemed to be cancelled, unless renewed by the Highway Administration.

That the Oil Company shall arrange all the clearances required for constructing the (ii) proposed access as per approved drawing himself. The applicant shall also arrange for shifting of utilities if required at his own cost as per the direction of the

concerned department.

That the issue of final formal permission including issuance of signed license deed (iii) should be duly certified by EE, CWD, Punjab PWD B&R Br., Ferozepur that the constructions have been carried out by the Owner of the fuel station in accordance with the drawing approved by the Highway Administration. The Oil Company shall energize fuel station after signing of license deeds by Highway Administration.

That Oil Company shall do necessary alteration including complete (iv) removal/shifting of the approach roads at its own cost if so required by Ministry, for the development of National Highway or in the interest of safety in this

EE, CWD, Punjab PWD B&R Br., Ferozepur shall immediately close or dismantle the (v) access in case the location becomes hazardous from traffic safety view point.

That the Oil Company shall not do or cause to be done in pursuance of the access (vi)

permission any acts which may cause any damage to Highway.

That the Oil Company shall not do or cause to be done, in pursuance of access (vii) permission, any act by which safety and convenience of traffic on the Highway shall be disturbed.

That the Oil Company shall ensure that proposed service road shall not be used for (viii)

parking purpose and there is no overflow of vehicles on approach road.

That height restrictions of building structure shall be as per local Govt. guidelines (ix) and the building line shall be as per the statuary requirements and IRC guidelines.

That the Oil Company shall install all the requisite road signs as per IRC: 67 & provide road markings as per IRC: 35 & in accordance with the Ministry's guidelines (x) dated 24.07.2013 to the satisfaction of EE, CWD, Punjab PWD B&R Br., Ferozepur.

That the Oil Company shall furnish two sets of fresh license deeds (duly indicating chainages of both new & old NH no.) in two originals drawn on new stamp paper as (xi) [1/2]

his namer of attornous the time of all signed by authorized signatory along with his power of attorney at the time of issue of final permission.

That the Oil Company shall while utilizing permission shall observe guideline relating to safety and connivance of traffic of the Highway, hygiene (in accordance with the requirement of Swachh Bharat Abhiyan), prevention of nuisance and pollution on the Highway.

Drinking water and toilet facilities shall be provided & maintained in hygienic conditions within the premise of the fuel station as per Ministry's guidelines and it (xiii) should be accessible to the public round the clock. A display board showing availability of such facility shall be installed before entry to the fuel station.

The applicant shall arrange all the clearances including forest clearance required for constructing the proposed access as per approved drawing himself. The applicant shall also arrange for shifting of utilities if required at his own cost as per the direction of the concerned department.

Regarding traffic safety, EE, CWD, Punjab PWD B&R Br., Ferozepur shall ensure that all safety features are provided as per the approved plan. (XV)

(xvi) That there shall be adequate drainage system on the access to the private property and inside its area so as to ensure that surface water doesn't flow over the highway or any water logging takes place.

(xvii) If the nearby BPCL RO (near chainage 169.408 km) upto which the applicant is proposing to extend and merge proposed 7.0m wide service road, does not construct their part of access, then the owner of subject retail outlet shall extend the access at their own cost so as to fulfil the guidelines at the time of taking final

(xviii) That the applicant shall not energize the fuel station without taking final access permission from this office.

- Development of National Highways is a continuous process and therefore the permission granted hereby for use of NH land doesn't restrict the development of NHs. Thus, the permission being granted hereby is temporary in nature. The provisional access permission granted hereby is without prejudice to Government to acquire applicant's land (plot of fuel station), if required for future development of National Highways.
- The applicant has submitted the fee for Rs. 2,81,421/- on 'Bharatkosh' online portal vide challan no. 2348641107200000564 dated 11.07.2020. In this regards it is to be mentioned that additional increase in license fee if needs to be submitted by the applicant at the time of final access permission.
- Notwithstanding to the above, the provisional NOC shall stand cancelled under the following circumstances:
- If any document/information furnished by the applicant proves to be false or if the applicant is found to have will fully suppressed any information. 4.1

Any breach of the condition imposed by the by the Highway Administration or the 4.2 officer authorized by the Administration on his behalf.

If at any later stage, any dispute arises in respect of the ownership of the land on which the Private Property is located or regarding the permission for change of land 4.3

This issues with the approval of RO MoRTH Chandigarh.
