For the purpose of Compensatory Afforestation (CA Land) for the aforementioned purposes, the Unit has identified 5 Hectares in the survey No's mentioned above.

With reference to S. No. 1 mentioned above, we are hereby submitting the DGPS Survey details, KML file and Master DGPS Survey Data of proposed CA land.

We request your good selves to verify and authenticate the ETS and DGPS / GNSS data of this CA land. We hereby confirm that the DGPS survey was conducted by tagging the survey data to the nearest SOIGCP at Bhadrachalam, as instructed in previous communications.

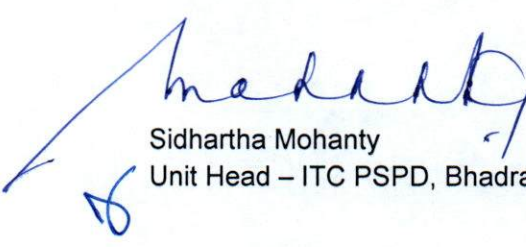
With reference to S. No. 2, this is to submit that the existing overhead lines were erected in 1979 and there have been no safety complaints/incidents registered over the last 43 years pertaining to these lines. We hereby confirm that all industrial safety norms as per Telangana State Electrical Board guidelines will be followed for erecting the new overhead electrical lines.

Since the pipeline passes through Farming land, underground electrical line installation is not recommended considering the safety aspects. We also hereby reiterate that the barest minimum forest land will be used for laying the proposed pipeline.

Accordingly, we request your good offices to favorably consider our proposal and provide necessary clearance.

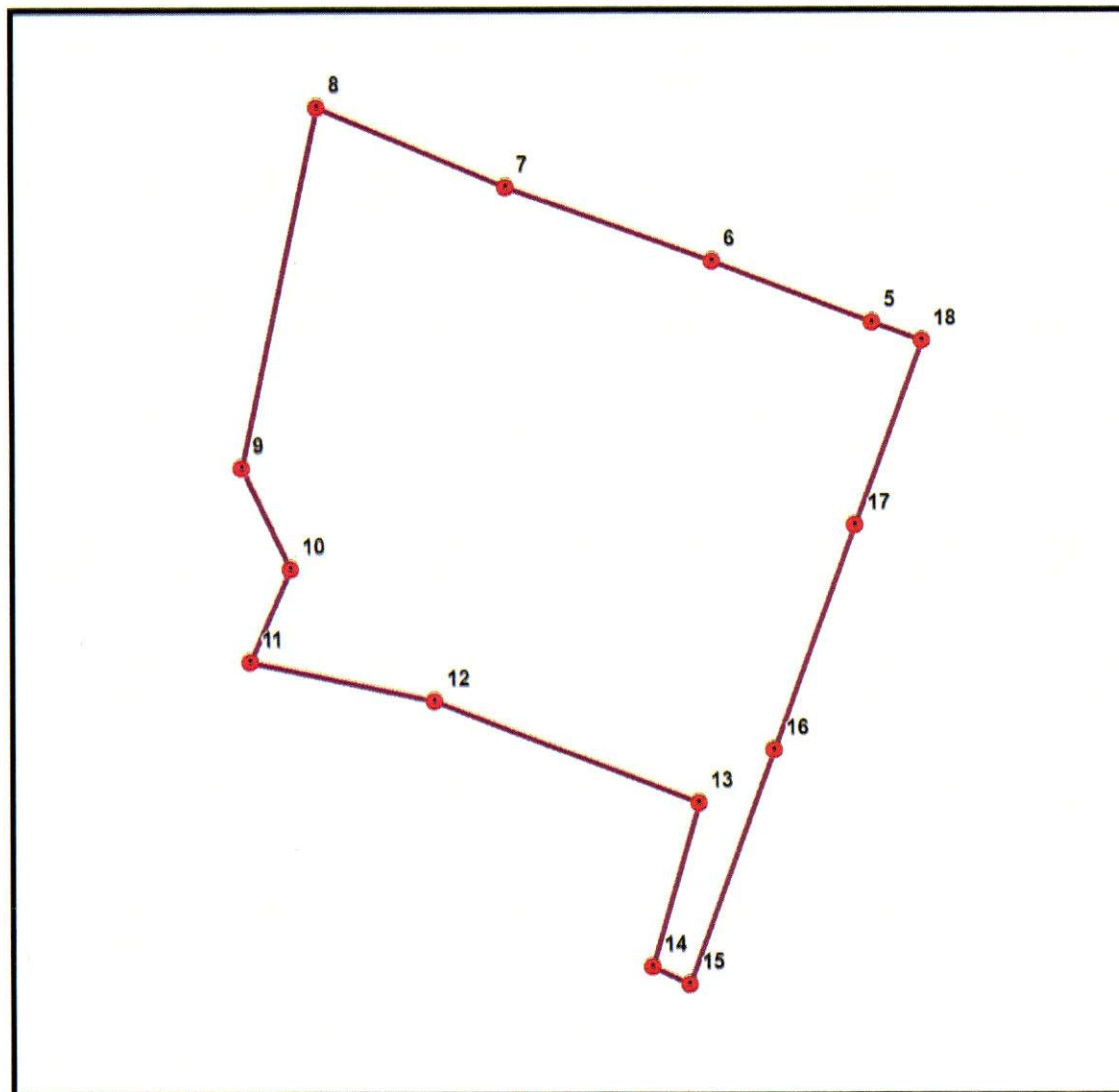

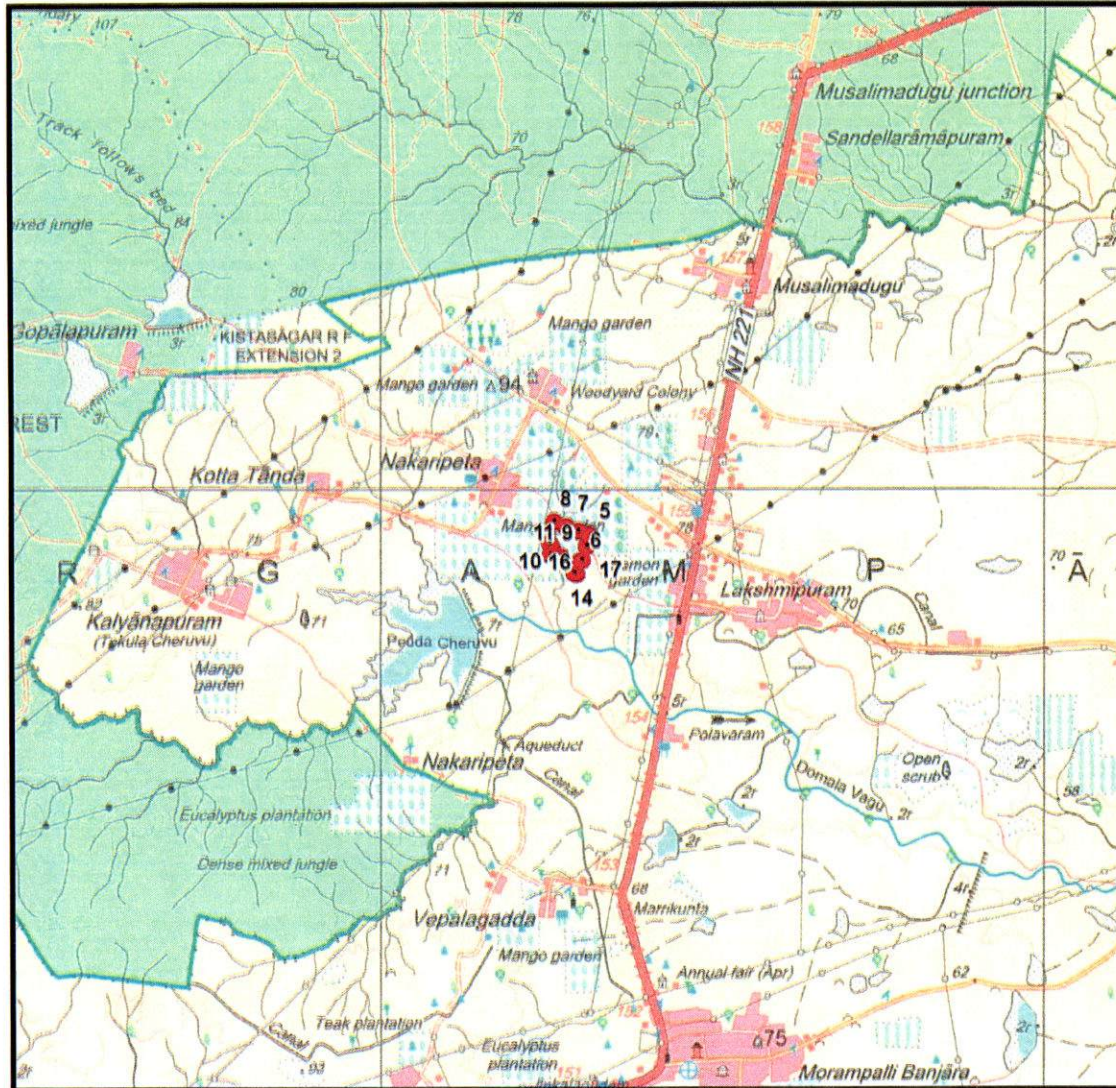

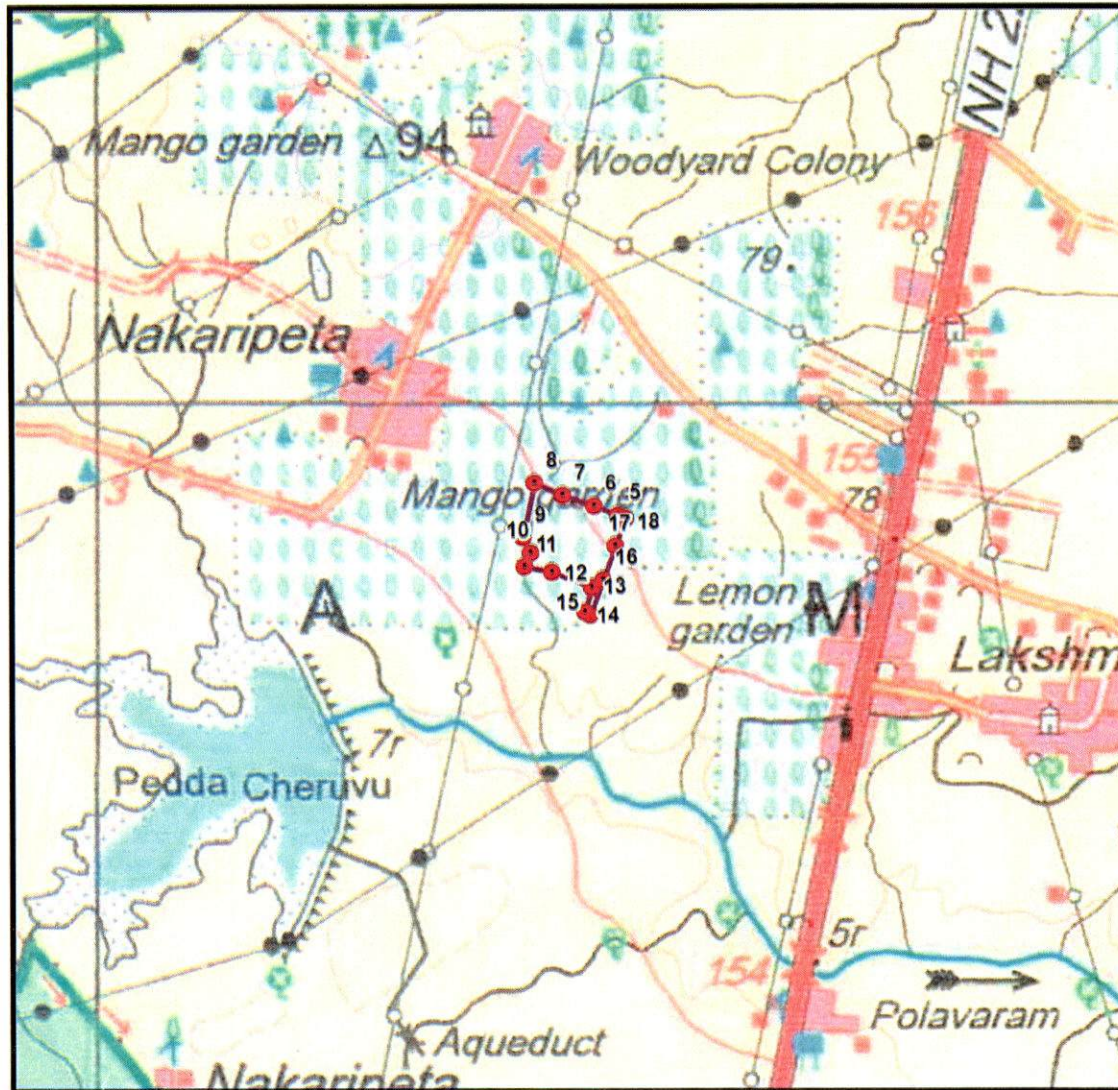
