Proposal for grant of access Permission to a proposed retail outlet of M/s IOCL Ltd, at Km. 83/497 TO Sub: 83/532 on NH-89 (RHS) in Khashra No. 209/108 of the Village -Shubhdand, Tehsil- Merta, Distrei -Nagaur in the state of Rajasthan.

ii) The EE, PWD, NH-division Ajmer letter's no dated 18.07.2019 received in this office dated 13.08.2019.

Sir,

An Online proposal on above mentioned subject was received from M/s IOCL. This office vide letter under reference i) has requested the EE, PWD, NH-division Ajmer to examine the proposal in accordance with Ministry's Guidelines issued vide letter No. RW/NH-33023/19/99-DO-III dated 24th July, 2013 and 25.08.2014 and furnish their comments along with recommendation and confirmation. The EE, PWD, NH-division Ajmer vide letter under reference ii) has submitted his report mentioning that the verified copy of the checklist and drawing is appended with the proposal. Based on proposal prepared by Consultant, certification by Oil Company i;e M/s IOCL., & recommendation and certification of Check List, Layout Plan, Drainage Plan and Location Plan by EE, PWD, NH-division Ajmer forwarded vide above mentioned letter under reference ii), the proposal is examined in this office in accordance with Ministry's Guidelines/ Norms issued vide letter No. RW/NH-33023/19/99-DO-III dated 24th July, 2013 and letter No. RW/NH-33023/19/99-DO.III dated 25.08.2014 and the proposal is granted "in-principle" approval and a provisional NOC subject to following conditions. One set of the original Layout plan, duly signed by the Regional Officer (Civil), Jaipur is enclosed. One set of Layout plan, has been retained in this office.

- a) The Oil Company shall construct the fuel station along with its access as per approved Layout drawings and provide drainage arrangement as per the approved drainage plan at their own cost within 6 (six) months of the issue of this Provisional NOC. After the construction as per approved drawings and to the satisfaction of Highway Administration, the final approval may be given within 30 days of the receipt of the communication from the applicant about the completion of construction work and License Deed may be signed by the Highway Administration. In case, the construction is not done in one year, the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration.
- The applicant should adhere to the undertakings given by them in compliance to par 7 to 10 of Appendix-I to Ministry's letter No. RW/NH-33023/19/99-DO-III dated 24th Jul 2013. It shall be ensured by the concerned Executive Engineery ( कुर्य किंग) 15. Managar (Redains) the undertakings made by the applicant are complied in किंग्य अपने केंग्रिक किंग्य क

अजमेर मण्डल कार्यालय / Ajmer Divisional Office अजमर / AJMER - 305006 03 09/20 would lead to violation of the Ministry's guidelines and the approval extended shall stand cancelled.

- c) Concerned Executive Engineer/Project Director, NHAI shall examine the road safety conditions during/consequent to construction of approaches. In case of any adverse conditions, the matter may be reported to this office. Compliance to the approved drawings and other conditions are to be ensured by them.
- d) After obtaining "in-principle" approval, the oil company/owner shall be responsible for construction and maintenance of acceleration/deceleration lanes, service lanes, channelizes, drainage arrangement, drinking water and toilet facilities in accordance with the approved drawing/lay out plan and specification conforming to the norms at his own cost in close coordination with Project Director/Executive Engineer & concessionaire.
- e) There should be a Public Drinking Water Facility and a Public Toilet Facility in the fuel station. The drinking water and toilet facilities shall be accessible to public round the clock. In order to inform the public about these, a display board showing availability of such facilities shall be installed before the entry to the fuel station.
- f) Oil Company will also ensure Video recordings before and after completion of work and CD of the above recording shall be submitted at the time of signing of License Deed.
- g) As per Ministry's guidelines, Demand Draft for Rs. 2,68,020/- as one time License Fee with 5 % increase in every calendar year payable to RPAO (NH), MoRTH, Jaipur has not been submitted, Same should be submitted at the time of Final NOC.
- This issue with the approval of Highway Administrator cum Regional Officer (Civil), MoRTH,
   Jaipur.
