

**Inspection report of Sri. Laxman Ranjeet Nayak, IFS., District Forest Officer, Bhadrabdi Kothagudem District on proposed Compensatory Afforestation Non forest land to an extent of 5.00 Ha in lieu of diversion of 4.2768 Ha Forest land for Laying of Water Pipe Line adjacent to existing pipeline from intake well at Iruvandi (V) of Burgampahad (M) of Manugur Division in favour of ITC, PSPD, Bhadrachalam on 13-06-2022.**

I have inspected the proposed Compensatory Afforestation Non forest land along with Forest Divisional Officer, Paloncha, Forest Range Officer, Paloncha, Forest staff and ITC, Bhadrachalam officials as instructed by Principal Chief Conservator of Forests (HoFF), Hyderabad State, Hyderabad vide reference No. 19582/2018/FCA-1, dated 10-06-2022. The proposed land is falling in Laxmipuram revenue village of Burgumpahad Mandal of Bhadrabdi Kothagudem District. As it is taking time for User agency (ITC, Bhadrachalam) to acquire land from Government and hand over to Forest Department, ITC, Bhadrachalam has proposed to handover their own land. Total extent of land available in Sy. No. 440/18/19 & 20 is 6.2 Ha out of which 5.00 Ha is demarcated for handing over to Forest Department.

**Physical details of land:**

Out of total **5.00 Ha** proposed for handing over, **3.75 Ha** of land is covered with mango plantation of 20 years old. The definition of 'forest cover', used in the ISFR, is "all lands, more than one hectare in area, with a tree canopy density of more than 10% irrespective of ownership and legal status". Hence, due to the canopy cover of mango plantation this can be considered as forest cover and taking over this land and notifying as reserved forest will further improve the forest cover by improving protection.

Further, **1.25 Ha** of land is having no growth and is fit for doing afforestation activity which will be included in CA scheme. The proposed land is surrounded by road (donka), Private land, Nala ITC (balance land) on South, North, West and South respectively.

As this land is a parcel an isolated patch surrounded by all revenue lands and is not a part of any continuous forest. But, the proposed area for handover is **5.00 Ha** this can be accepted and further developed as instructed by MoEF&CC F.No.11-423/2011-FC dated 22-02-2019.

Hence, this NFL CA land can be accepted by taking up planting in DFL land of **3.75 Ha** and incorporating the same in CA scheme and user agency will be informed to take up chain link fencing before handing over of land to avoid further issues if any.

ITC Limited – PSPD Unit: Bhadrachalam was set up at village Sarapaka in Burgampahad (M), of Bhadravati Kothagudem District in the year 1976 and the commercial operations started in the year 1979.</p> <p>The Government granted permission to draw 15 MGPD water from River Godavari which was subsequently increased to 17.6 MGPD by the Government of Telangana.</p> <p>Due to passage of time and regular wear and tear, the pipeline was worn out and there are many leakages all along the pipeline resulting in huge loss of fresh water. In this context ITC has engaged M/s. Tata Consulting Engineers (TCE) Mumbai to assess the stability and strength of existing pipeline. M/s. TCE has recommended for replacement of pipeline with a new line beside the existing pipeline.</p> <p>The total length of pipe line is around 5.62 Km, from intake well at Iruvendi (village) to raw water intake at Sarapaka Village out of which a length of 3 Km, to an extent of 4.2768 Ha. is falling in the Kistasagar Reserve Forest Block, Aswapuram range of Manuguru Forest Division Area.</p>






**Map Showing CA Land against Forest Area Proposed for



Burgampahad Mandal, Managur Division in favour of ITC Ltd Bhadrachalam


