This has reference to the EDS raised online on 03.08.2021 on the online proposal no. FP/DL/SCH/139664/2021 regarding the shortcomings in the above-mentioned proposal.

Point wise reply to the same are given below:

1. **Approval from the apex court is not enclosed only recommendation from RMB is provided. Please provide the same.**

**Reply:**

The approval from the apex court in form of Order in W.P.(C) 202/1995 dated 24.03.2022 is attached in **Annexure- 1**.

2. **Justification for the proposal is not satisfactory, please provide the same.**

**Reply:**

The School of Planning and Architecture (SPA), an "Institution of National Importance" created under an Act of Parliament, is under the Ministry of HRD, Government of India. The School dates back to the year 1942 when it started with just one Department and today it has grown up to twelve Departments, along with several Centres of Excellence and National and International collaborations with several countries. The School attracts the best students who wish to pursue careers in architecture and planning. In view of the demand for the professional education in the

field of Architecture and Planning, it has been envisioned that the current student strength be enhanced from approximately 1200 students to about 2800 students in the next ten years. Accordingly, a number of undergraduate and 3 post-graduate courses are in the pipeline in addition to the expansion of Doctoral Studies.

This land was allotted by the DDA to the SPA New Delhi vide letter dated 27<sup>th</sup> Dec 1983. Thereafter, SPA had purchased the land by making the requisite payments to DDA on 9th November 1987. The land continued to be under the physical possession of SPA since then and re-demarcation of land for the purpose of statutory approvals was carried out vide letter dated 12<sup>th</sup> August 2014 of DDA. The SPA could not construct campus at this land because of the court cases pertaining encroachment, which took time to resolve.

Considerable expenditure has already been made in procurement and securing the land and its watch and ward by SPA. Any change in land under possession is not possible by SPA since the Government approvals have been obtained from the nodal Ministry i.e. Ministry of HRD, Government of India. The Ministry of HRD, Government of India (Higher Education Funding Agency) has also sanctioned Rs. 370 crore for this project. The plans for the project have been prepared by the CPWD of the Government of India. The following approvals for development of this project have already been obtained :

- Delhi Urban Art Commission (DUAC)
- Airport Authority of India
- Fire Service Department
- Archaeological Survey of India
- Allocation of Compensatory afforestation land

In view of the milestones mentioned above, any change in location or re-allotment of land at this point of time will nullify the progress made till date, negatively impacting the future growth of the institution.

The institution has taken all measures to develop this project considering that the 8 ha land allotted to SPA, was fit for the construction of the project.

This 8 ha land allotted in 1983, by DDA, was part of the 92 ha "constraint area" and was considered fit for the construction of the project at that point in time. Furthermore, it may be noted that DDA had allotted surrounding lands within the same layout to other buildings. Almost allottees have completed their construction and these premises are occupied and operational today. Furthermore, over time, roads have been developed along the two sides of the proposed site and there is no connectivity with the greens around and that of Sanjay Van.

From the point of view of the institution, the allotted site is also ideally located in south Delhi in proximity to the two existing academic campus of SPA at ITO and residential campus at Maharani Bagh.

As far as forest/ trees are concerned then total number of trees present are 2495. Only 1091 which fall under the building footprint will be cut. Majority of trees on the site are of *Prosopis Juliflora*, colloquially known as 'Vilayati Kikar'. It is an invasive Mexican species, which causes harm to the native flora of the region. It has the ability to grow in dry areas and rocky surface as its tap root system enables it to draw water from deeper grounds, resulting in depletion of the ground water table. Some other negative impacts of *P. juliflora* are summarized below (Source: Delhi's Ridge, G.N. Sinha, 2014):

- Its invasive nature has resulted in formation of thick mono-specific scrub.
- It depletes soil nutrients.
- It has a poisonous spine which is harmful to livestock and people.
- It impairs the growth of forage (grasses).
- It reduces total biodiversity of area by reducing their abundance, distribution and ecosystem function.

The forest department is taking all measures to prevent the invasion of *P. juliflora* in Delhi and encourage the growth of indigenous and native species.

Therefore, establishment of the project at this location along with the requisite tree cutting will not cause significant ecological impact despite being located in deemed forest area due to the nature of trees and disconnect from surrounding areas.

Furthermore, on establishment of the campus, plantation shall be undertaken within the project as well such that there is 1 tree/ 80 sq.m. of the plot area (as per MoEF&CC Office Memorandum F. No. 19-2/2013-IA-III dated 9th June, 2015). The additional plantation shall be of native species and aid in improving the biodiversity within the project site.

### **3. Alternate site option is not provided.**

**Reply:** The current site is already an alternate to the originally allotted site, as explained below:

School of Planning and Architecture was initially allotted a site measuring 20 acres in the area west of JNU, adjacent to Hill View apartments houses constructed by DDA, in 1983. The site was handed over to the School sometime in 1988. Subsequently it was decided by Delhi Development authority that the large chunk of area (approx. 400 ha) lying between Vasant Vihar and Vasant Kunj should be planned and developed which should include hotel sites, commercial area, institutional area and a large component of foreign missions. A plan was prepared and was discussed with the Delhi Urban Art Commission and was subsequently approved by them. According to the new plan the location of the Institutional land (public and semi-public facilities) was shifted to the South and South west of this site near Vasant Kunj. The basic reason for re-siting was that the earlier site was falling in Air Funnel and it was considered that the Institutions should not fall under the Air Funnel. Subsequent to the approval of the plan from DUAC, a sector plan was prepared where the new site was earmarked for School of Planning & Architecture. This was approved by the

Screening Committee of DDA. Thus, the revised site was handed over to the School in lieu of the old site.

Thus, the proposal is for this new site, which was last re-demarcated in 2014 over the total area of 80073.07 sq.m. or 8.0073 ha by Delhi Development Authority. Since this is an allotted land, which has already been re-sited due to the reasons stated earlier, the School is planned to be establish on this site only.

Furthermore, DDA has allotted compensatory afforestation land (shown in **Annexure-2**). Land use of the compensatory afforestation site at Dwarka (Pocket-5) is recreational/ green and as per terms and condition no. 3, it is mentioned that the status of the green land shall be changed subsequently to "Protected Forest". (refer **Annexure-3**).

We hope you will find the above reply in order and process our application for forest clearance at the earliest.

**I.A.No.25905 Of 2021:**

**This application has been filed by the State of Himachal Pradesh to relax the restrictions imposed on diversion of forest land under the Forest (Conservation) Act, 1980 ('FCA') and under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA) vide order dated 11.03.2019 with the following prayers:**

**(a) relax the restrictions imposed on**

diversion of forest land under the Forest (Conservation) Act, 1980 and under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, vide order dated 11.03.2019.

(b) allow the State of Himachal Pradesh to issue formal orders for diversion of forest land under the Forest (Conservation) Act, 1980 for construction of 16 projects mentioned in para 8 supra and detailed in Annexure A-5 and all other projects that may be envisaged by the State in future in accordance with the provisions of Forest (Conservation) Act, 1980 or other statutes governing the field.

(c) To allow the State of Himachal Pradesh to issue formal orders for diversion of forest land under Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 for construction of 263 projects mentioned in para 9 supra and detailed in Annexure A-6 and all other projects that may be envisaged by the State in future in accordance with the provisions of Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 or other statutes governing the field.



16 projects referred to in prayer clause (b), the details of which have been given in para 8 of the application, have been approved by FCA. The learned Amicus Curiae Mr. A.D.N. Rao submits that permission can be granted for construction of these 16 projects. In respect of prayer clause (c) which pertains to granting of permission under FRA for construction of 262 projects detailed out in para 9 of the application, the learned Amicus Curiae submitted that permission sought by the State of Himachal Pradesh can be granted subject to an undertaking being filed by the State regarding compensatory afforestation for the area of 191.4121 hectares that requires to be diverted for the said projects.

Permission sought for diversion of the forest land under FCA for construction of 16 projects as mentioned in Para 8 and prayer clause (b), and under FRA for construction of 263 projects mentioned in para 9 and prayer clause (c) is granted subject to the State filing the aforementioned undertaking within a period of four weeks from today.

**IA Nos. 20662 AND 20676/2021:**

These applications are filed by the National Highway Authority of India seeking permission to fell 170 trees in Kiluramala Reserve Forest of Palagur Village in Madurai North and 77 trees in Alagarmalai Reserve Forest in Dindigal Forest.

Having heard Mr. P.V. Yogeswaran, learned counsel appearing for the applicant and Mr. A.D.N. Rao, learned Amicus Curiae, we are of the opinion

that these applications deserve to be allowed. Therefore, the applications are allowed subject to the applicant obtaining all statutory clearances, as required.

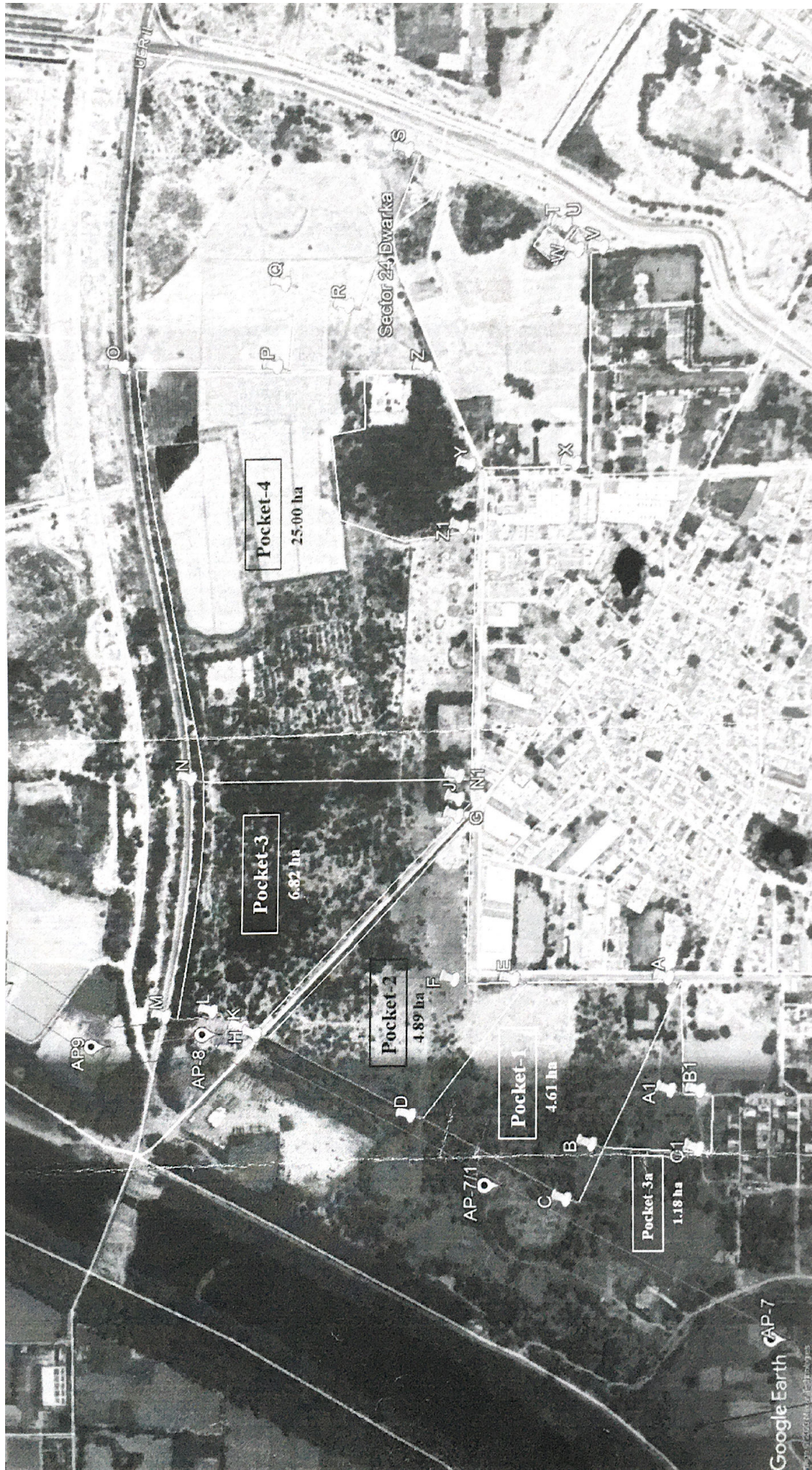
