As per land detail mentioned in proposal are received from BL&LRO, Rajganj that LR plot No.03, Sheet No. 11, JL No. 01 is presently recorded in the name of Deputy Commissioner of West Bengal in LR-Khaitan No. 01 . In this regard this unit also approached to BL&LRO again to rectify query raised by DFO,Baikunthapur vide this unit L/No. 1820 dated 23-07-19. In turn of this letter BL&LRO, Rajganj apprised that Forest department identify Forest area as compartment wise but as per their record the concerened plot has been depicted in map & recorded in R-O-R since Revisional settlement vide letter No. 1608/BL&LRO/RAJ/JAL/2019 dated 31-08-19.
3. Name of village mentioned in proposal (Part-I) filled by this unit vide Part-01 form para No. B-2.3 (Village wise breakup) where option seen only village name Jungle mohal but it is to your kind information that area mentioned for diversion of land. nearest village fall in Rajphapri which is not mentioned in Part-I form option in Forest web site.
4. It is also to mentioned you that after clearnace from your good office that 12.5 hectares Forest land can be available for transfer vide your office Letter No. 85/8-1 dated 10/01/018. After that this unit requested to your office for servey of Forest Land vide this office L/No. 6727 dated 12/06/2018 and your good office further ordered to Range Officer, Salugara Range for physically present in Course of the Survey. In presence of Range Officer survey of 12.5 Hectres Forest Land carried out on 16/12/2018.
5. It is requested that Part-II of the subject issue may be uploaded at the earliest as considerable time has been lapsed since submission of documents & our higher HQrs is pressing hard due to non-finalization of the subject issue.

Sub: Diversion of 70 Acres (28.34 Hectares) of Forest Land.  
Ref: Discussion held in the chamber of the undersigned.

In reference to your above noted communication, the impediment faced by the undersigned is mentioned herein below: -

The total area for compensatory afforestation to be taken up is double the area proposed for diversion i.e. 56.68 Hectares. A detailed survey was carried out by Range Officer Sarugarah Range to check the availability of Blank area suitable for the said plantation. But only 25 Hectares could be obtained in 3 patches. The balance area of 31.68 Hectares is available in smaller patches of less than 5 Hectares in different Ranges. Hence the same will be difficult for creation as well as maintenance and supervision.

Therefore in absence of sufficient area for compensatory afforestation, this is to communicate that out of the area of 28.34 Hectares sought for transfer in order to establish the Battalion Headquarter for 93 - Bn Battalion, 12.5 Hectares can be made available for transfer so that compensatory afforestation for 25 Hectares can be ensured.

This is for your kind information and taking necessary action.






