TO WHOWSOEVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt) dated 3rd August 2009 wherein the MOEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 where in MoEF issued certain relaxation in respect of linear projects, it is certified that **4.986 Hectares** of forest land proposed to be diverted in favour of **Superintending Engineer, TDWSP (RWS&S) Circle, Mahabubnagar** for laying of pipe lines & construction of Sumps for providing safe drinking water in (a) **Ambagiri H/o Appaipally, Chennampally gate H/o Errapenta, of Lingal Mandal** (b) **Amarabad-Thirmalapur BK, Kummaronipally-Rayalagandi thanda, Vankeshwaram to Chitlamkunta, Chitlamkunta-Chennampally, Chitlamkunta - Udimilla, Udimilla-Maradugu, Maradugu x road-Ippalapally, Ippalapally to Pallerutipenta, Pallerutipenta x road-Maddimadugu Villages of Amarabad Mandal** (c) **Rangapur-Umamaheshwaram Temple, Bommanpally-siddapur & Ghanpur-Bakkalingasanipally Villages of Achampet Mandal** falls within jurisdiction of Nagarkurnool Reserved Forest.

It is further certified that:

- The complete process for identification and settlement of rights under the FRA has been carried out for the entire **4.986 Hectares** of forest area proposed for diversion. A copy of records of Resolutions of GP's and No ROFR pattas certificates of RDO, Mahabubnagar are enclosed.
- The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Grama sabhas have given their consent to it;
- The proposal does not involve recognised rights of Primitive Tribal Groups and Pre - Agricultural Communities.
