With reference to above cited subject, previously the Ghatti- Basavanna Drinking Water Supply Project involves the diversion of 575.0749 Ha of forest land in Gokak, Godachinmalki, Konnur villages of Gokak Forest Division and Mavanur village of Belagaum Forest division. Further, vide Ref-1, an EDS was raised by MoEF&CC, New Delhi on 23.02.2024 to shift the proposed non-site specific activities like Dam view point, Utility, Dam office and Guest House to suitable non-forest land. As discussed with the DDGF (C) & DIGF, Regional Office, Bengaluru during their site visit to project site on 05.04.2024, the Dam office and Guest house (4.50 Ha) in forest area is retained due to strategic requirement and the view point (8.45 Ha) and utility component (1.054 Ha) is dropped including the steps and approach road connection to Dam view point was removed. Accordingly, the forest land requirement has been revised from 575.0749 Ha to 564.3421 Ha.

Land required for the project is as follows;

i) Forest Land-564.3421 Ha.

ii) Non Forest land-63.0144 Ha.

In view of the above, it is hereby requested to provide the area editing option to change the area of the forest diversion area in the Parivesh Portal.
