
Subject: Regarding land diversion of Govt. Polytechnic Lahaul & Spiti at Udaipur.  
Sir,

I have the honour to refer to your office letter Endstt. no. 939-41 dated 01.07.2025 on the subject as cited above. In this regard, as desired the steps as initiated by the institution are appended below:-

1. That, vide aforesaid letter, it was directed that, since there is large nos. of cutting of trees/sapling on the construction site, as such direction was given to institution to explore the possibility of vertical expansion of building blocks.
2. That, Institution has taken the aforesaid matter with the Chief Architect (Central Zone) HPPWD, Mandi, and requested to prepare the revised layout plan by adopting the vertical construction practices and proposing the construction only in those areas having low density of forest cover on the construction site. 3. That, Chief Architect (Central Zone) HPPWD, Mandi, has initiated the matter and direction has been given to Executive Engineer, Chenab Valley Division HPPWD, Udaipur in this regard. (Copy Enclosed).
4. That, as per direction contained in your office letter no. 939-41-dated 01.07.2025, Joint Inspection has been conducted by SDM Udaipur on dated.11.08.2025.



Subject: Request to provide the layout plan for the buildings of Govt. Polytechnic Udaipur, Dist. Lahaul Spiti, to be constructed at Udaipur (Distt. Lahual & Spiti).

Sir,

I have the honour to intimate your good self that direction has been received from the Govt. of Himachal Pradesh, that all the construction works of various Govt. Department's Buildings are to be executed through the Himachal Public Works Department (H.P.P.W.D.).

In the matter as stated above, it is intimated that the construction of the various buildings of Govt. Polytechnic, Udaipur, Distt Lahaul Spiti is planned to be constructed in the Khasra No. 24/12/1 & Khasra No 8/1 at Udaipur, Distt Lahaul Spiti (**Copy of the Tatima attached – A1**). The case regarding diversion of forest land of 2.0435 hectares in favour of Director of Technical Education Vocational & Industrial Training for construction of Govt. Polytechnic at Udaipur Lahaul & Spiti under FCA 1980 is under process. The aforesaid case was submitted through Parivesh portal to Ministry of Forest and Environment (MoEF & CC) for the diversion of forest land to Non-Forest use as per the FCA 1980. The Institution has received the deficiency relating to cutting of large number of trees and saplings in the aforesaid Khasra no. and it has been proposed to rationalize the layout of the site plan, so that there is minimum no. of tree fallings in the forest area.

Keeping in view above, it is proposed to prepare the layout plan of buildings by considering the existing density of forest cover & by adopting the vertical rise constructional practices (as per prevailing norms), so that there is lesser number of cutting of trees in the forest area. It will help the Institution to put up case strongly by mentioning the exact number of trees/saplings, which will be axed for the purpose of executing the construction in the forest area.


Institution has proposed to construct two numbers of Blocks i.e. Civil Engineering Block (Academic Block) and Administrative-cum-Amenity Block in Khasra No. 24/12/1. The suggestive space area requirement for various blocks is also attached herewith (**Annexure A2**). Beside this, access road/footpath is also required to be provided for the purpose of providing access to the aforesaid blocks & a playground is to be provided in the Khasra No 8/1.



It is requested that the building layout plan along with the detail regarding the exact numbers of trees to be axed for the purpose of executing the construction of various blocks may be provided to the Institution at earliest, so that the deficiency as raised by MoEF &CC can be removed, please.



- 4 Geological site investigation report/ soil bearing capacity etc.

It is, therefore, requested to supply the above cited site data/ information to this office, so that the planning and designing could be initiated accordingly. The revenue record of the selected land of Government Polytechnic Udaipur, District Lahaul & Spiti (HP) is enclosed herewith for ready reference please. DA/ As above.
