With Reference to the above cited subject, Vide Reference letters (1) and (2), an extent of 449.55 Ha forest land under Koppa, Badravathi and Shivamogga Divisions of Forest Department has been diverted to Upper Tunga Irrigation Project (FP/KA/IRRIG/332/1997). Vide Reference letter (3) Executive Engineer, VJNL, Upper Bhadra Project Division-2, B R Project has requested to provide a Letter of Consent for Re-Diversion of 7.53 Ha of forest land which is required for Upper Bhadra Project, Package-1 Transmission line work.


In the refernece letter (3), Executive Engineer, VJNL, Upper Bhadra Project Division-2, B.R.Project has stated that, the extent of 7.53 Ha of forest land in Kanagalakoppa village (Sy No: 20,59,60,58,69,56 and 55) of Shivamogga district and K.Kanaburu (Sy No: 99,98,97,82 and 83), Muttinakoppa (Sy No: 73) of Chikkamagaluru village is required to carryout the 220 kV Transmission line work of 35m width Corridor under Upper Bhadra Project, Package-1. The land proposed for Re-Diversion was earlier diverted for Upper Tunga Project (UTP Reservoir). Since the work of carrying out 220 kV transmission line of 35m wide corridor is compatible with the primary

use (UTP Reservoir) and does not hinder the earlier purpose of land use and also both Upper Tunga Project and Upper Bhadra Project will come under same Parent Department (Water Resources Department), hereby it is giving a consent to Re-diversion of 7.53 Ha forest land in Kanagalakoppa village of Shivamogga district and K.Kanaburu, Muttinakoppa of Chikkamagaluru village for Upper Bhadra Project without paying any payment to Executive Engineer, Karnataka Neeravari Nigama Limited, Upper Tunga Project Division, Shivamogga (Primary User Agency).





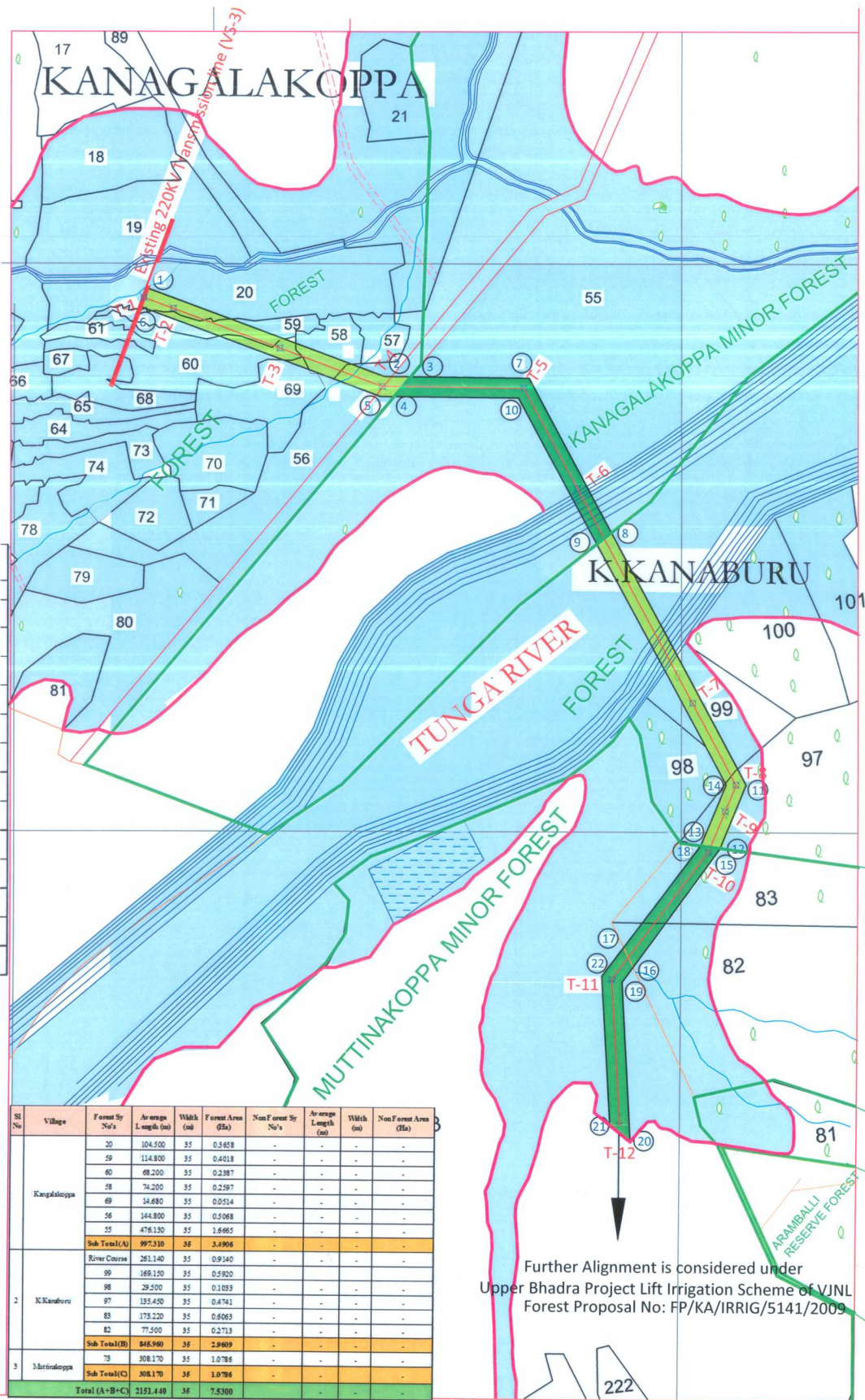
