

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

5-1: A Proposal has been received by this office from अधिशासी अभियन्ता, 8 वॉ वृत्त, लो0नि0वि0, चम्बा for diversion under (FCA-1980) of 0.7875 ha. of forest land non-forestry purpose. The project envisages the use of forest land for construction of जनपद टिहरी गढवाल के विधान सभा क्षेत्र टिहरी में राज्य योजना के अन्तर्गत टिहरी चम्बा मोटर मार्ग के कन्या जूनियर हाई स्कूल चवालखेत होकर बुडोमी गांव तक मिसिंग लिंक मोटर मार्ग नव निर्माण। The site inspection of the land involved in the proposal has done by me on date-31/08/2021.
