Therefore, you are hereby requested to make payments through e-payment module of forest clearance portal "Parivesh.nic.in" as for the direction of the Government of India and as per this office demand notice by uploading the demand notice for acceptance by the Principal Chief Conservator of Forests (Head of Forest Force), Bangalore and get the Challan generated from the said portal.

Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supree Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government to the User Agency. The User Agency has to abide to that and shall furnished an undertaking to this effect.

After the completion of the payments process, you are requested to submit the compliance report to this office for further needful action.
