Reliance Jio Infocomm Ltd., Visakhapatnam, subject to the condition that the proposed work to be carried out without felling of any tree growth and fulfillment of all other conditions stipulated by the Government of India, Ministry of Environment, Forests & Climate Change in the letters 2nd read above.
