Sub: Diversion of 14.0567 Ha. (Revised from 16.8014 Ha.) of Forest land in various Sy.Nos of Thoppahalli, Mandyala, Sunnakal, Yendaguttapalli, Royalpad and Guntapalli villages (Nachagadda MF, Madarankapalli MF & Royalpad SF) in Srinivasapura Taluk, Kolar District for widening (Two-laning with Paved Shoulder) of existing State Highway (SH-82) from Chintamani to Andhra Pradesh border (total length 39.80Km) under Karnataka State Highway Improvement Project (KSHIP-III) in favour of the Executive Engineer, KSHIP Division, Tumkur

With reference to the above subject, it is to inform that, the PCCF (HoFF) Bangalore vide letter cited under reference (3) above has submitted the proposal to accord approval for diversion of 16.8014 ha. of forest land for widening of (Two Laning with Paved Shoulder) of existing State Highway (SH-82) from Chintamani to Andhra Pradesh border under Karnataka State Highway Improvement Project (KSHIP-III) in favour of the Executive Engineer, KSHIP Division, Tumkur.

After examining the proposal on the basis of the approval of the Regional Empowered Committee (REC) in its meeting dated 17-2-2022, the MoEF & CC, Government of India have accorded in-principle (Stage-I) approval of the Central Government for diversion of 14.0567ha. (out of 16.8014ha. proposed) of forest land (excluding the area proposed for Toll Plaze & Rest area to an extent of 2.7447ha which is not Site Specific Activity) in various Sy. No's in Srinivasapura taluk for widening of (Two laning with Paved Shoulder) of existing State Highway (SH-82) from Chintamani to Andhra Pradesh border under Karnataka State Highway Improvement Project (KSHIP-III) in favour of the Executive Engineer, KSHIP Division, Tumkur vide letter cited under ref (1) above, subject to fulfillment of certain conditions.

The same has been forwarded by the Government of Karnataka vide ref (2) and the PCCF (HoFF) vide ref (3) to this office for submitting the compliance report As per the conditions stipulated by the GOI, the User Agency has to transfer the Net Present Value (NPV), the cost of raising and maintenance of Compensatory Afforestation (CA) in non-forest land identified under this proposal and the cost of felling of trees in the diverted forest land. In this regard to enable this office to take action to submit compliance report, a demand notice has been issued towards payment of NPV and CA as under:


