I enclose herewith a copy of the letter cited along with statutory proforma proposal under Forest (Conservation) Act, 1980, submitted by the Principal Chief Conservator of Forests (Head of Forest Force), Andhra Pradesh, Guntur, for diversion of 0.45 ha of forest land in Compartment Nos.308, 309, 310 & 312 of Rapur-Yerragonda RF, Compartment No.333 of Rapur Veligonda Block "A" Extn "B" RF and Compartment No.331 of Rapur-Veligonda Block Extn "C" RF, Nellore Division for laying of Optical Fiber Cable (OFC) in favour of Authorized Signatory, M/s Vindhya Tele Links Ltd., Secunderabad.

- I am to inform that the User Agency i.e., M/s Vindhya Tele Links Ltd., Secunderabad has uploaded the subject proposal (Proposal No.FP/AP/OFC/81411/2020) in the Government of India, Ministry of Environment, Forests & Climate Change, web portal (www.parivesh.nic.in) for prior approval of the Central Government under Section-2 of the Forest (C) Act, 1980. The User Agency has justified that the area required for laying of the OFC is the bare minimum considering the requirements and also considering the safety of cables so laid. Since the Telecommunication cables also carry the communication from the Government offices, Defense and strategic establishments, and from the differential industrial organizations apart from the general public, for the safety and confidentiality of the conservation so made it not advisable to lay such important cables on the private land belonging to different parties. The cable alignment will be suitable diverted to avoid any cutting of trees and laid within the road land boundary by excavating a narrow trench of 0.47 m. width. The same strip of trench will be reinstated to its original condition. It is also intimated that no structure will be erected on the cable route. The project does not involve felling of trees as OFC is laid within the Road Boundary along the Road only. The User Agency has furnished RoFR Certificate in form-I issued by the District Collector, SPSR Nellore and also undertakings for payment of NPV, Addl. NPV, CA and tree extraction charges etc.
- 3. Further, I am to inform that the District Forest Officer, SPSR Nellore has recommended the proposal in Part-II. The Conservator of Forests, Guntur has agreed with the information provided in Part-II by the District Forest Officer, and also recommended the proposal in Part-III. The Nodal Officer (FCA), Andhra Pradesh has recommended the proposal in Part-IV. The State Government of Andhra Pradesh recommend the proposal in Part-V, which is enclosed herewith.

4. I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forests & Climate Change, under Section 2 of Forest (Conservation) Act, 1980, for diversion of 0.45 ha of forest land in Compartment Nos.308, 309, 310 & 312 of Rapur-Yerragonda RF, Compartment No.333 of Rapur Veligonda Block "A" Extn "B" RF and Compartment No.331 of Rapur-Veligonda Block Extn "C" RF, Nellore Division for laying of Optical Fiber Cable (OFC) in favour of Authorized Signatory, M/s Vindhya Tele Links Ltd., Secunderabad, at the earliest.
