Sub : Proposal for diversion of 0.3752 Ha. of forest land for construction of road from Lending Turning to Barchangay Village under Singtam Range in East District of Sikkim by Roads & Bridges Department, Govt. of Sikkim - In Principle approval reg.

Sir,

Reference your [No. FP/SK/ROAD/37514/2018 received through on-line/off line mode and after careful examination of your proposal, the State Govt. is hereby pleased to accord the **stage-I (In-Principle) Approval** in terms of the General approval as conveyed by the Ministry of Environment, Forests & Climate Change, Govt of India, New Delhi under section 2 of Forest (Conservation) Act 1980 [vide letter No.F.No.11-9/98 FC, dated 03/01/2005 and subsequently letter No.F.No.11-9/98-FC dated 13/2/2014 for **diversion of 0.3752 Ha. of forest land for construction of road from Lending Turning to Barchangay Village under Singtam Range in East District of Sikkim by Roads & Bridges Department, Govt. of Sikkim**, subject to fulfillment of following conditions :-

- (1) The User Agency shall transfer the cost of **Rs. 6,37,614.00** (Rupees six lakhs thirty seven thousand six hundred and fourteen) only for Compensatory Afforestation over double the area in degraded forest land i.e. 0.7504 ha identified at Burung Khasmal under Singtam Range East Territorial Division to the Adhoc CAMPA through State Forest Department.
- (2) The User Agency shall pay and transfer the payment of **Rs. 2,46,506.00** (Rupees two lakhs forty six thousand five hundred and six) only for Net Present Value (NPV) of the forest land being diverted for the project proposal as per the Order of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide letter No. 5-3/2007-FC dated 05/02/2009 in this regard.
- (3) At the time of payment of the Net present Value (NPV) at the present rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per final decision of the same by Hon'ble Supreme Court of India.

- (4) All the above funds (CA cost, NPV etc) shall be deposited in favour of the Principal CCF-cum-Pr. Secretary, Forests Environment & Wildlife Management Department Govt. of Sikkim, Gangtok for onward deposition under State Compensatory Afforestation Fund under Major Head " 8336-Civil Deposit MIH-103-SCAD as per recent guidelines.
- (5) The boundary of the forest land being diverted shall be demarcated on the ground at the project cost by erecting four feet high reinforcement cement concrete pillars each inscribed with its serial number, DGPS coordinates, forward and back bearing and distance from adjoining pillars.
- (6) The charges for felling, logging and transportation of project affected trees for Rs. 70,985.00 (Rupees seventy thousand and nine hundred and eighty five) only shall be paid by the User Agency at the rates approved by the State Govt. and deposited separately in favour of the Principal CCF-cum-Pr. Secretary, Forests Environment & Wildlife Management Department Govt of Sikkim, Gangtok.
- (7) The expenditure like boundary walls, stone pillars, demarcation charges, cost of damage of trees the funds on these account should, be deposited with the DFO concerned.
- (8) The user Agency shall obtain the Environmental Clearance as per the provisions of the Environment (Protection) Act, 1986, before consideration of final approval, if required.
- (9) The user agency will have to obtain the Forest (Conservation) Act, 1980 clearance for stone, river sand, river boulder in forest land, if necessary.
- (10) As per Ministry's letter No.11-30/96-FC (Pt) dated 14.09.2001, if the compliance of stipulated conditions is awaited from the State Government for more than 5(five) years the in-principle approval would summarily be revoked considering that the user agency is no longer interested in the project.

After fulfillment of the above conditions in completeness, the User agency shall submit the **compliance report** for seeking the Final Approval of the State Govt. under the said Act. **Diversion of forest land shall not be effected till the final approval is granted by the State Govt. in this respect. Demand Note in respect of Conditions No. (1) , (2) & (6) are also enclosed for realization of payment.**


