With reference to the above cited memo on the captioned subject, the following observations are made,

(a) Site Specific Wildlife Conservation Plan - The previous approved Site Specific Wildlife Conservation Plan for Rs.1,22,53,200/- @ 286.30/- per MD has already been approved by the PCCF (Wildlife) & Chief Wildlife Warden, Odisha vide his letter no. 10885 dt.20.12.2019 for financial forecast of Rairangpur Forest Division. The User Agency has also deposited the same amount on dt.19.07.2021 vide UTR No. SBIN52021071933549822. Now it is to recast the wage rate of financial outlay on the basis of revised current minimum wage rate @ 315/- per MD for Rairangpur Forest Division amounting to Rs.1,27,90,800/- (Rupees One Crore Twenty Seven Lakh Ninety Thousand Eight Hundred) only. Hence, you are requested to deposit the differential amount of Rs.5,37,600/- (Rupees Five Lakh Thirty Seven Thousand Six Hundred) only at the earliest.

(b) Avenue Plantation - You are requested to deposit the approved of the financial outlay for Avenue Plantation Scheme with the stretches of road of NH-220 coming under the jurisdiction of Rairangpur Forest Division for the above project amount of Rs.1,00,04,748/- (Rupees One Crore Four Thousand Seven Hundred Forty Eight) Only at the wage rate of @ 315/- per MD.

Site Specific Wildlife Conservation Plan for the aforementioned project has been approved and communicated to you in this office letter No.10885 dt 20.12.2019 at a financial forecast of ₹274.344 lakh (Rupees two crore seventy-four lakh thirty-four thousand four hundred) only in compliance to the additional condition stipulated by State Government in their letter No.16560/F&E dt 30.07.2018 while forwarding the letter No.5-ORC358/2018-BHU dt 18.07.2018 of Government of India, MoEF&CC, ERO, Bhubaneswar granting Stage-I approval to the above forest diversion proposal.

The Field Director, STR-cum-Regional Chief Conservator of Forests, Baripada Circle in his Memo. No.810 dt 16.03.2022 has submitted a proposal for revision of financial outlay on the basis of current minimum wage rate of ₹315/- per manday. In this context, it is pertinent to mention here that the Labour Commissioner, Odisha has revised the minimum rate of wages vide notification No.5639/LC dt 02.11.2021 and the present rate of minimum wages including VDA per day with effect from 01.10.2021 now stands at ₹315/-.

On consideration of the proposal submitted by the Field Director, STR-cum-Regional Chief Conservator of Forests, Baripada Circle, the financial outlay of the approved Site Specific Wildlife Conservation Plan is revised to ₹285.096 lakh (Rupees two crore eighty-five lakh nine thousand six hundred) only for the following activities.
