Vide reference 1<sup>st</sup> cited, the G.O.I., MOEF has accorded stage-I approval for Diversion of 1.99 Ha., of Forest land in favour of Superintendent of Police Bhadadri Kothagudem District for setting up of Police/CRPF CAMP for anti extremist operation duties in interstate bordering areas near Chennapuram Village, Thippapuram South beat, compt.No.71B, Thippapuram section Charla Mandal & Range.

The Total Demand has been arrived to an amount of Rs.**74,17,569**/-(Rupees Seventy four Lakhs seventeen thousand five hundred and sixty nine only). The User Agency has to deposit the said amount in two different accounts i.e., Telangana state compensatory afforestation fund account Rs.61,72,389/- and in Forest Divisional Officer Bhadrachalam Account Rs.10,45,180/-and an amount of Rs.2,00,000/- to be deposited into the Forest Divisional Officer, Paloncha. Further the user agency is requested to make payment of compensatory levies like the Cost towards Raising and maintenance of Compensatory Afforestation /Net present value (NPV) to an amount of Rs.61,72,389/- through e-payment portal, by uploading the demand notice at <a href="http://parivesh.nic.in">http://parivesh.nic.in</a> and generating the challan after approval of Nodal Officer and to transfer funds against the Challan generated for the project. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at <a href="http://parivesh.nic.in">http://parivesh.nic.in</a>.

Further, the cost towards construction of boundary pillars and tree extraction charges to an amount of Rs.10,45,180/- shall be deposited into PD account of Forest Divisional Officer, Bhadrachalam account bearing No.37080101171, IFSC Code:SBIN0020163 of State Bank of India, Bhadrachalam **and** an amount of Rs.2,00,000/- shall be deposited in to the FDO, Paloncha PD Account Bearing No. 62153093987, IFSC Code: SBIN0020160.

It is submitted that the user agency shall deposit the NPV in Telangana Compensatory fund Management and planting authority (CAMPA) through online at Ministry Portal. The User Agency has to upload the demand notice at Ministry's Portal against the project, generate challan after approval nodal officer and then deposit the funds against the Challan generated. The User Agency is requested to furnish the condition wise compliance report along with undertaking and further documents as per the conditions stipulated by the G.O.I., MOEF F.No.4-TSB227/2021-HYD/367 Dated:11-02-2022 communicated in PCCF.,Rc.No.2938/2021/FCA-4, Dated:11-02-2022 immediately to this office without any delay. So, that this office can able to submit the same to higher authorities and also requested to comply with the following in accordance with the MoEF&CC, GoI instructions issued vide F.No.7-23-2012-FC,dt.24.07.2013 communicated vide Prl.Chief Conservator of Forests, A.P., Hyderabad Rc.no.45921/2001/F4, dt.23.08.2013.

- 1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central Government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the Project proponent for the use of forest land for the non-forest purposes.
- 2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

The transfer of forest land to User Agency shall not be affected prior to the issue of final approval stage-II clearance and no work in violation shall be carried out.
