Sub: TSFD – F(C) Act 1980 – Diversion of 1.971 Ha. of Forest land in Bhadradi Kothagudem District – Road Net work in back ward areas – For widening and upgradation of the existing road from Kudunuru to Bodugudem of Bhadrachalam Division under LWE-PMGSY-XI Project – Proposals forwarded by the PCCF,TS, Hyderabad- stage-I approval accorded by the G.O.I., MoEF. - Demand notice submitted for approval -Reg.

Vide reference cited, the State Govt. has accorded stage-I approval for Diversion of 1.971 Ha., of Forest land in favour of Executive Engineer, Panchayatraj Division, Bhadrachalam, for upgradation of existing road from Kudunuru to Bodugudem of Pedamidisileru R.F. of Dummugudem Range of Bhadrachalam Division of Bhadradi Kothagudem District for Development and transportation purpose and for basic amenity creation up to the remotest villages, subject to fulfillment of certain conditions stipulated therein.

The total Demand has been arrived to an amount of Rs.18,53,646/- for this project. The User Agency has to deposit the said amount in two different accounts i.e., Telangana State compensatory afforestation fund Account (Rs.13,78,446/-) and Forest Divisional Officer, Bhadrachalam Account (Rs.4,75,200/-) as detailed below.

Further the Executive Engineer, Panchayatraj Division, Bhadrachalam is informed that the proposed project is passing through the Reserve Forest Pedamidisileru to a length of 1971 meters. Therefore, 192 Nos. of concrete pillars of 4 feet height are required @ 20 meters interval with an amount of Rs.1,63,200/- (96 Nos.x2=192X850 Per No.) and 26 Nos. Broad base pillars of 4 feet height @ interval of 500 meters/at the entry or exit of the RF to an amount of Rs.3,12,000/- are required as per condition no.(2) of GoRt.No.170.

Accordingly as per the instructions, a draft demand notice is prepared and the details are as follows.

The Executive Engineer is requested to furnish the condition wise compliance report along with undertakings and further documents as per the conditions stipulated by the Government of Telangana G.O.I.MoEF and Climate change(FC) Division, New Delhi Lr.F.No.5-2/2017-F.C., dt.28.03.2019., G.O.Rt.No.170,dt.02.11.2020 communicated in PCCF, TS Hyd ref.2187/2019/FCA-II, dt.06.03.2021, immediately to this office without any delay. So, that this office can able to submit the same to our higher authorities.
