2	The boundary of the forest land to be diverted shall be suitably demarcated on ground at the project cost as per the direction of concerned Divisional Forest Officer.	The demarcation of forest land to be diverted will carried out as per the direction of concerned Divisional Forest Officer.
3	The cost of raising plantation of ten times the number of trees to be falled shall be realised from the user agency. The location of the area identified for raising the plantation shall be furnished for considering Stage-II clearance. The location of the area for raising plantation is to be identified by the Forest dept. with the help of Revenue authourities.
4	The State Government shall charge the Net Present Value for 0.3542 ha. 5	Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the user agency. The user agency shall furnish an undertaking to this effect.	Additional amount of the Net Present Value after revision of the same by Hon'ble Supreme Court of India if any will be deposited.

7	State Government shall complete settlement of rights, in term of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006, if any, on the forest land to be diverted and submit the documentary evidence as prescribed by this ministry in it's letter No. 11-9/1998-FC dated 3rd August 2009 read with 05.07.2003, in support therepf.	There is no scheduled Tribes and other Traditional Forest Dwellers residing on the forest land to be diverted Form II given by D.C D.K District enclosed.
8	The layout plan of the proposal shall not be changed without prior approval of Central Government.	Shall be followed
9	No labour camp shall be established on the forest land.	No labour camp will be established on the forest land.

10	The forest area shall be used for the purpose for which it is granted. The total forest area utilized for the project shall not exceed 0.3542 ha.	Forest land to be diverted will be utilized only for formation of approach road, power line, Intake well, jack well and water pipe line. The total forest area utilized for the project will not exceed 0.3542 ha.
11	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.	The forest land proposed to be diverted will not be transfer to any of the agencies, department or person.
12	The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.	Agreed.
