Please refer to the letter No. Ft.48-4097/2019(FCA) dated 06-08-2020 (Copy attached) from Addl. Chief Secretary (Forests) to the Govt. of Himachal Pradesh, Shimla on the subject cited above where in the "sanction in Principal" for diversion of 0.3185 ha. of Forest land in the favour of HPPWD for the Construction of Bridge on 40 meter span on Dayol to Lasani road 0/00 to 8/670 under (PMGSY) over Pryal khad.(sub/head:-Construction of Bridge approaches from Dayol side 0/00 to 0/385), has been accorded. In this regards, it is intimated that the amount of NPV and CA stands deposited in respective heads. The compliance report has been uploaded on dated 09-10-2020 by the user agency on the e-portal (<https://parivesh.nic.in/>), and the hard copy has been sent to the Divisional Forest Office Jogindernagar vide letter No. 12738 on dated 09-10-2020. The detail of same along with point wise reply of conditions of 'in-Principal' approval is as under:-
