विषय:- जनपद सम्मल की तहसील सम्मल के ग्राम पवांसा की खसरा/गाटा सं०-325 पर सम्मल-बहजोई मार्ग(एस०एच०-51) के किमी० 79 की बांयी पटरी पर मै० भारत पेट्रोलियम कार्पोरेशन लिमिटेड, बरेली द्वारा विकसित किये जा रहे रिटेल आउटलेट (पेट्रोल पम्प) के सम्पर्क मार्ग में प्रभावित 0.1777 (संशोधित 0.1041) हे० संरक्षित वन भूमि के गैर वानिकी प्रयोग एवं 02 वृक्षों के पातन/ट्रांसप्लान्ट की अनुमति के सम्बन्ध में। (Online Proposal No. FP/UP/Others/47337/2020)

कृपया उपर्युक्त भारत सरकार पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय क्षेत्रीय कार्यालय, लखनऊ की पत्र संख्या 8बी/यू०पी०/०६/९०/२०२२/एफ०सी०/११६ दिनांक 29.08.2024 (छाया प्रति संलग्न) जो अधोहस्ताक्षरी एवं आपको पृष्ठांकित है का अवलोकन करने का कष्ट करें। इस सम्बन्ध में अवगत कराना है कि प्रश्नगत प्रकरण में भारत सरकार के उक्त सन्दर्भित पत्र दिनांक 29.08.2024 द्वारा कतिपय शर्तों के अधीन सैद्धान्तिक स्वीकृति निर्गत की गयी है। सैद्धान्तिक स्वीकृति में उल्लिखित शर्त संख्या 1 से 23 तक के सम्बन्ध में मुख्य वन संरक्षक/नोडल अधिकारी, उ०प० लखनऊ के कार्यालय पत्रांक 2501/11-सी दिनांक 24.05.2016 द्वारा निर्धारित प्रपत्र में पूर्ण बिन्दुवार अनुपालन आख्या तथा मुख्य वन संरक्षक एवं मुख्य कार्यकारी अधिकारी, उत्तर प्रदेश कैम्पा लखनऊ की पत्र संख्या 384/2-37-2(ई-पेमेन्ट पोर्टल) दिनांक 14.09.2015 में दिये गये निर्देशानुसार वॉच्छित सूचना/अभिलेख/प्रमाण-पत्र (मूल में) यथाशीघ्र इस कार्यालय को उपलब्ध कराने का कष्ट करें ताकि विषयक प्रकरण में प्रभाग स्तर से अग्रेत्तर कार्यवाही की जा सके:-

S.No.	Condition
1	Legal status of the forest land shall remain unchanged.
2	Compensatory afforestation shall be taken up by the Forest Department in an area of 0.2082 ha. Degraded Forest Land in Compartment No. 1 Village Sihali Jagir Forest Block, Range & Tehsil Hasanpur, District Amroha (JP Nagar) at the cost of user agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided के क्रम में प्रस्तावक विभाग द्वारा 335 पौधों के रोपण व उनके 10 वर्षों के अनुरक्षण हेतु आवश्यक धनराशि रु० 146600.00(मु० रु० एक लाख छियालीस हजार छः सौ मात्र) ई-पेमेन्ट पोर्टल के माध्यम से कैम्पा नई दिल्ली में जमा कर पावति रसीद की प्रति इस कार्यालय को उपलब्ध करायी जायेगी।
3	The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
4	The State Government shall charge the Net Present Value (NPV) for the 0.1041 ha. Forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2023, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the

	guidelines issued by the Ministry vide Letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006, 5-3/2007-FC dated 05/02/2009 and 5-3/2011-FC(Vol-I) dated 06.01.2022 in this regards. के कम में प्रस्तावक विभाग द्वारा आवश्यक धनराशि रू० 99705.00(मु० रू० नित्याने हजार सात सौ पाँच मात्र) ई-पेमेंट पोर्टल के माध्यम से कैम्पा नई दिल्ली में जमा कर पावति रसीद की प्रति इस कार्यालय को उपलब्ध करायी जायेगी।
5	Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the user Agency. The User Agency shall furnish an undertaking to this effect.
6	User Agency shall restrict the felling of trees to 02 trees/minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the user agency with the State Forest Department.
7	Separator island has to be maintained as Green Belt, in consultation with DFO. Green Belt plan on separator island shall be approved by DFO. ensuring appropriate site specific species. Green Belt plan shall also include species to be planted on the periphery of retail outlets and service road, if applicable. Green Plan in respect of Separator island /entry & exit/service road as applicable and duly approved by DFO. be submitted along with compliance report.
8	Around periphery of the establishment should be lined up with tree plantation at a close spacing of 1.0 to 1.5 meter keeping an offset of 1.5 meter from the boundary with light crown trees which will maintain greenery without compromising with the land requirement of the establishment.
9	User Agency and authorized signatory oil company issuing sanction letter shall be liable for land use including tree plantation for entry/exit and Separator island strictly as per the approved layout plan and any violation/non adherence shall attract penal action/prosecution in competent court of jurisdiction as per Van (Sanrakshan Evam Samvardhan) Adhinyam. (1980) Rules and Guidelines.
10	Green Plan duly approved by DFO in respect of separator island/entry/exit/service road as applicable be submitted and Geo Tagged six monthly reports be maintained at retail outlet and be submitted six monthly.
11	The FRA certificate as per Ministry's guidelines shall be submitted before the issuance of final approval. The complete compliance of the FRA 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
12	No violation of FCA certificate from concerned DFO shall be provided.
13	Greenery will be maintained by user agency around Periphery of Fuel Station.
14	User agency shall use the land between entry and exit for plantation and conservation of trees, the same shall be demarcated by 2 feet wall.
15	Plantation shall also be done along the inside boundary of Fuel Station.
16	Certificate of DFO certifying that the proposed RO is not in close proximity of any existing RO in accordance with MORTH guidelines dated 24-07-2013 has to be provided.
17	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
18	The period of diversion under the approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
19	The KML file of area to be diverted, the CA areas, the proposed SMC work, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the E-Green watch portal with all requisite details before commencement of work.
20	The violation of any of the conditions stipulated under this approval will be liable to the cognizance and appropriate action under MoEFCC rules and Guidelines as applicable specifically MoEFCC Guidelines dated 15/05/2023, authorizing officers of the rank of

	Divisional Forest Officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or Union territory Administration concerned, having jurisdiction over the forest land in respect of which any offence under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is committed or violation of the provisions of the said Act has been made to file complaints against such person/authority/organization prima-facie found guilty of offence under the Act or the violation of the rules made thereunder in the court having jurisdiction in the matter.
21	Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
22	All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/)
23	The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/)
