कृपया उपरोक्त विषयक सचिव (वन), उत्तर प्रदेष शासन के पत्रांक पी–143 / 81–2–2023–800(169) / 2023, दिनांक 27.06.2023 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रकरण में राज्य सरकार द्वारा वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 के अन्तर्गत भारत सरकार की स्वीकृति मांगी गयी थी।

प्रष्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 08.01.2024 द्वारा कतिपय शर्तों के साथ सैद्धांतिक स्वीकृति प्रदान की गई थी, जिसकी अनुपालना उपरोक्त संदर्भित पत्रों के माध्यम से प्रेषित की गई है। प्रस्तुत अनुपालना के परीक्षणोपरान्त मुझे आपको यह सूचित करने का निर्देष हुआ है कि केन्द्र सरकार जनपद मुरादाबाद में भारतीय राष्ट्रीय राजमार्ग प्राधिकरण, मुरादाबाद द्वारा मुरादाबाद—काषीपुर मार्ग (एन०एच0—734) के किमी0 389.00 (प्रस्तावित किमी 0.00) से 39.750 तक (प्रस्तावित किमी0 चैनेज संख्या—39.750) तक चौड़ीकरण एवं सुदृढ़ीकरण हेतु 63.5796 हे0 संरक्षित वनभूमि के गैरवानिकी प्रयोग एवं बाधक 11277 वृक्षों व 32859 पौधों कुल 44136 वृक्षों/पौधों के पातन की विधिवत् स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है :—

- 1. Legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up by the Forest Department in an area of 127.35 ha. (DFL) Degraded Forest Land at the cost of the User Agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided. The details of CA are as follows:-

- The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the 3.
- User agency shall restrict the felling of trees to 44136 trees/minimum numbers in the diverted forest land 4. and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- Plantation shall be raised on both sides of the road and median (if available) by the State Forest Department 5. at the cost of User Agency according to IRC guidelines and order passed by NGT in OA no. 27/2015 in the
- matter of Babulal Jaju v/s State of Rajasthan and others dated 16.11.2015 as per submitted scheme. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest 6.
- The user agency shall provide suitable under / over pass in Protected Area / Forest Area as per 7.
- The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental 8.
- The layout plan of the proposal shall not be changed without prior approval of Central Government. 9.
- 10. No labour camp shall be established on the forest land.
- 11. The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- 12. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 13. No additional or new path will be constructed inside the forest area for transportation of construction
- 14. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in
- favour of the user agency or the project life, whichever is less. 15. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 16. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 17. The KML file of area proposed for diversion and area proposed for plantation shall be uploaded on
- the E-Green watch portal with all requisite details before commencement of works. 18. Annual 3rd party monitoring and concurrent internal monitoring by State Forest Department shall be done
- and monitoring reports submitted to this office. 19. The User Agency and the State Government shall ensure compliance of all the Court orders, provisions,
- rules, regulations and guidelines for the time being in force as applicable to the project.
- 20. Project Completion Report and Stage-II compliance report shall be submitted within a period of 6 months
- 21. The violation of any of the conditions stipulated under this approval will be liable to the cognizance and appropriate action under MoEFCC rules and Guidelines as applicable, specifically MoEFCC Guidelines dated 15/05/2023, authorizing officers of the rank of Divisional Forest Officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or Union territory Administration concerned, having jurisdiction over the forest land in respect of which any offence under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is committed or violation of the provisions of the said Act has been made, to file complaints against such person/authority/organization, prima-facie found guilty of offence under the Act or the violation of the rules made thereunder, in the court having jurisdiction in the matter.
- 22. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, (1980), and action would be taken as per the MoEF&CC Guideline F.No. 11-42/2017-FC dt.
- 23. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
