With reference to the subject cited above, it is brought to your kind notice that, the District Forest Officer, Peddapally has issued a demand notice to pay the charges for NPV, SZA and other charges under CA PD to the General Manager, RG-III, SCCL vide reference 7<sup>th</sup> cited for Rs.398,90,11,615/-. Accordingly, the General Manager, RG-III, SCCL has paid an amount of Rs.34,31,29,747/- to Adhoc CAMPA Telangana. The balance amounts are still pending from User Agency i.e., General Manager, RG-III, Singareni Collieries Company Limited. In continuation to this the CA schemes are approved and forwarded by the Conservator of Forests, FDPT & Kawal Tiger Reserve, Mancherla and Chief Conservator of Forests, Kaleshwaram Circle to the District Forest Officer, Peddapally vide reference 8<sup>th</sup> and 10<sup>th</sup> cited to issue a revised demand notice for payment of compensatory levies.

In this regard, The General Manager, RG-III, Singareni Collieries Company Limited is requested to deposit the following amounts towards compensatory levies to the following accounts concerned as mentioned in the below table.

In view of the above, the User Agency is requested to deposit the compensatory levies towards CA, NPV etc. into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account through online mode only, through e-portal method at MoEF & CC, GOI, New Delhi portal i.e., <http://parivesh.nic.in> by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at <http://parivesh.nic.in>

**If the User Agency is delayed the payment, the penal NPV will be increased with interest as per the condition of GOI, MoEF & CC, New Delhi. If that is the case, the User Agency is requested to approach the District Forest Officer, Peddapally for revision of Demand Notice.**

Further, the User Agency is requested to comply with the following in accordance with the instructions issued by the GOI, MoEF&CC, New Delhi vide F.No.7-23/2012-FC, dt:24.07.2013 communicated vide PCCF's Rc.No.45921/2001-F4, dated:23.08.2013 and publish the orders at the cost of the project proponent.

1. Publish the entire forest clearance granted in verbatim along with the conditions and safeguards imposed by the Central Government in two widely circulated daily newspapers i.e., one is vernacular language and the other in English granted to the proponent for the use of forest land for the non-forest purpose.



2. The copies of the Forest Clearance should also be submitted to the heads of local bodies, Panchayaths and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

Further, the user agency is requested to furnish compliance report along with all the required relevant information/document etc., and undertaking for the related items comply the Condition Nos. (ii, iii, iv, vi, vii, x, xi) etc., as stipulated in Stage-I approval and other conditions at the earliest, so as to submit the condition wise compliance report to the higher authorities for obtaining Stage-II approval. The User Agency is informed that the transfer of forest land to User Agency shall not be affected prior to the issue of final approval of Stage-II clearance (or) working permission whichever is earlier and no work in violation shall be carried out.
