


In compliance of Ministry of Environment and Forest (MoEF) Govt. of India's letter No. F 6-35/2012/32 dated 28 March, 2013 where in the MoEF issued guidelines on submission of evidenced for having initiated and completed the process of settlement of rights under the schedules tribes and other traditional forest dwellers (Recognition of Forest Rights) act 2006 (FRA for short) on the forest land proposed to be diverted for non forest purpose read with MoEF letter No. 2888 dated 4<sup>th</sup> May 2017 where in MoEF issued certain relaxation on respect of linear projects, it is certified that 1.83 Hact land proposed to be diverted on favour of Executive Engineer PHED Shivpuri (Name of the user agency) for Providing Laying Jointing Testing 1100 mm dia NP3 & NP4 RCC pipe from Karbala towards Ghasari farm (purpose for diversion of forest land) in Shivpuri district falls within Jurisdiction of Madhav National Park Shivpuri.

**IT IS FURTHER CERTIFIED THAT:-**

- A. The complete process for identification and settlement of rights under the FRA has been carried out for the entire 1.83 Hact. of forest area proposed for diversion. A copy of records of all consolation letter of the Forest Rights Committee. (s) Gram Sabha (s) Sub division level committee (s) and district level committee are enclosed as annexure 01 to 03 annexure.
- B. The proposal for such diversion (with full details of the projects and its implication under vernacular/local language) have been placed before each concerned Gram Sabha of forest dwellers, who are eligible under the FRA.
- C. The each of concerned Gram Sabha has been carried out and they have given their consent to the proposed diversion and the complication and ameliorative measures. If any having understood the purpose and details of proposed diversion. A copy of certificate issued by the Gram Sabha of village Kota enclosed as annexure 01 to 03.
- D. The discussion and decision on such proposals has taken place only when there was quorum of minimum 50% of the members of the Gram Sabha present.
- E. The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gram Sabha has given his consent to it.
- F. The rights of primitive Tribal Groups and Pre- Agricultural communities. Where applicable have been specially safeguarded as per section 3(1)(e) of the FRA.
