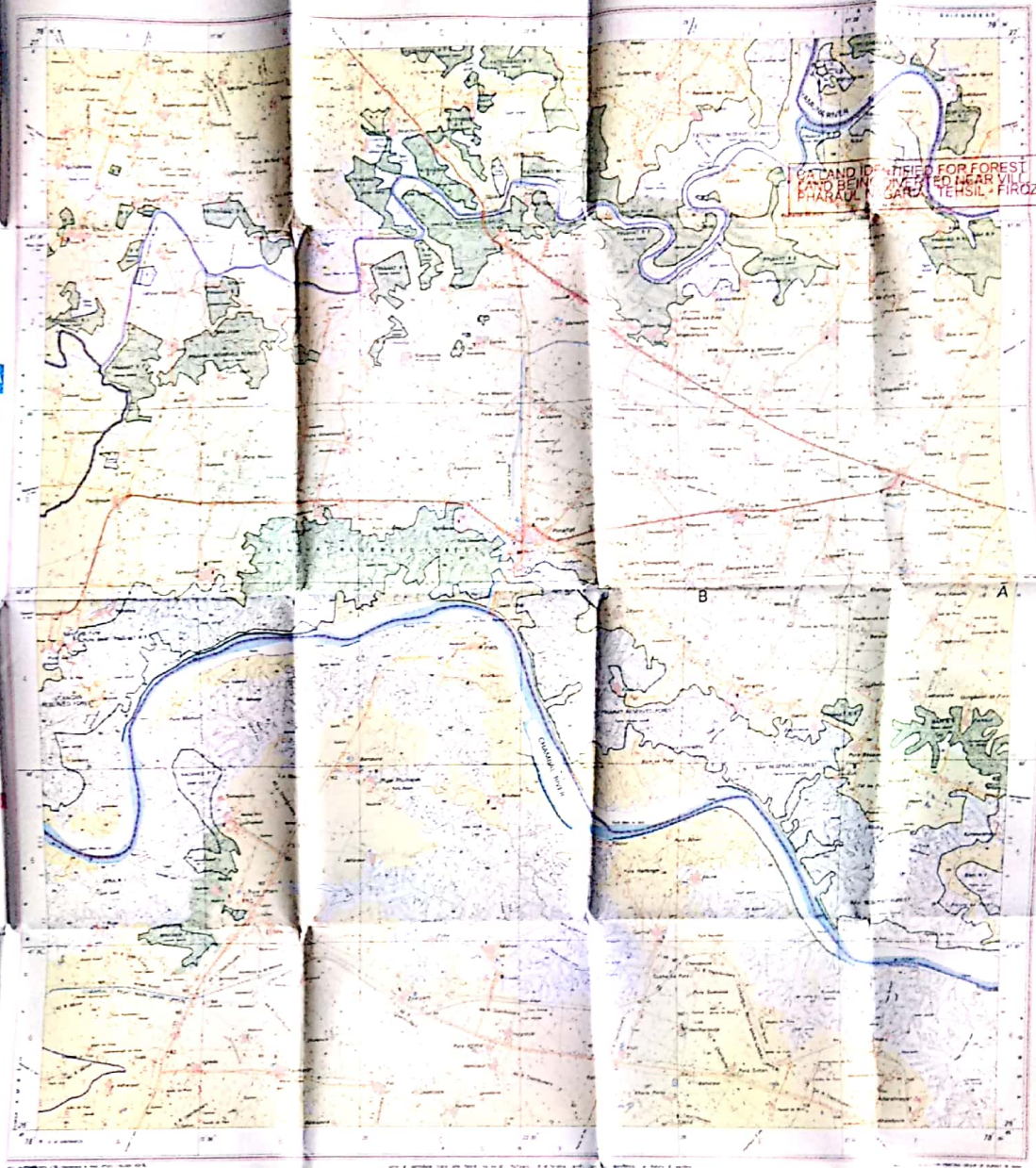
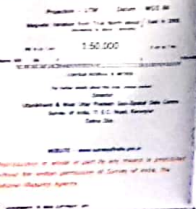
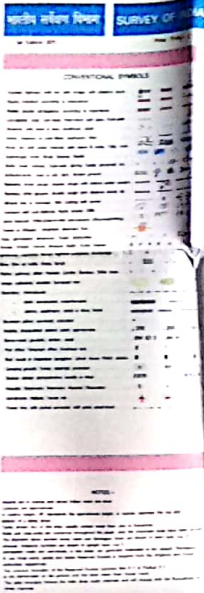
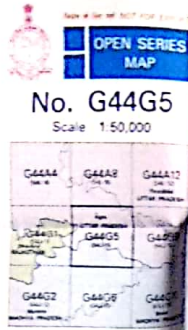
COMPENSATORY AFFORESTATION MAP
