ORDER:-

The Director of Mines & Geology, Hyderabad vide reference 2nd cited has granted a Quarry Lease in favour of M/s. Vaishnav Granites, Prop:Sri.C.Sivakumar Reddy for Black Granite over an extent of 4.900 Hectares in Compartment No. 213 of Paradarami Reserve Forest., Chittoor West Division, Yadamari Mandal, Chittoor District for a period of 10 (Ten) years.

In view of the above, sanction is hereby accorded to M/s. Vaishnav Granites, Prop. Sri. C.
