



In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No-11-9/98-FC(pt.) dated 3<sup>rd</sup> August, 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition) of Forest Rights) Act, 2006 on the forest land proposed to be diverted for non-forest purpose, read with MOEF's letter dated 5<sup>th</sup> February 2013 wherein MOEF issued certain relaxation in respect of linear project, it is certified that **37,808 hectare** of forest land proposed to be diverted in favour of **Himachal Pradesh Public Works Department** GoHP for the **Construction of link road from Saila Mathla to Luhani Km. 0/0 to 5/205** in Chamba District falls within the jurisdiction of **Chudana & Lohani** village in Tehsil Bhattiyat, District Chamba.

It is further certified that: -

- a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **37,808 hectare** of forest land proposed for diversion. 


