It is informed that, vide reference 3<sup>rd</sup> cited, the Principal Chief Conservator of Forests, (HoFF), Andhra Pradesh, Guntur has verified the maps and authenticated area arrived for diversion in Katarukonda RF is 4.73 Ha.

In this connection, it is to inform that as per the Forest (C) Act, 1980 and the Rules and Guidelines made thereunder, whenever a forest land is to be diverted for non-forestry purposes, the equivalent non forest land has to be identified for compensatory afforestation and funds for raising compensatory afforestation are to be imposed and for certain activities additional conditions are imposed. Further, the non-forest land for Compensatory Afforestation (CA) are to be identified contiguous to or in the proximity of Reserved Forest or Protected Forest, as far as possible. In case, non-forest land for CA is not available in the same district, non-forest land for CA is to be identified anywhere else in the State/Union Territory. If non forest land is unavailable in the entire State/ UT, funds for raising CA in double the area in extent of the forest land diverted need to be provided by the user agency.

Therefore, the Executive Engineer, W.R.D, M.I Works Division, Kurnool is requested to identify the compensatory Afforestation land as per the Forest Conservation Act, 1980 for taking further action in this matter.


