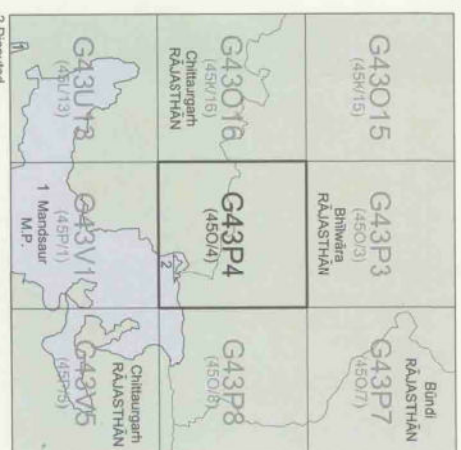

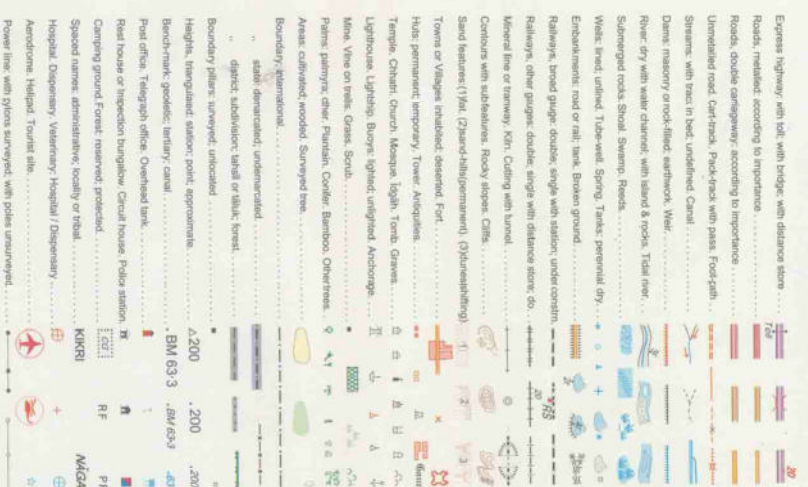

(Decreasing by about 1° East annually)



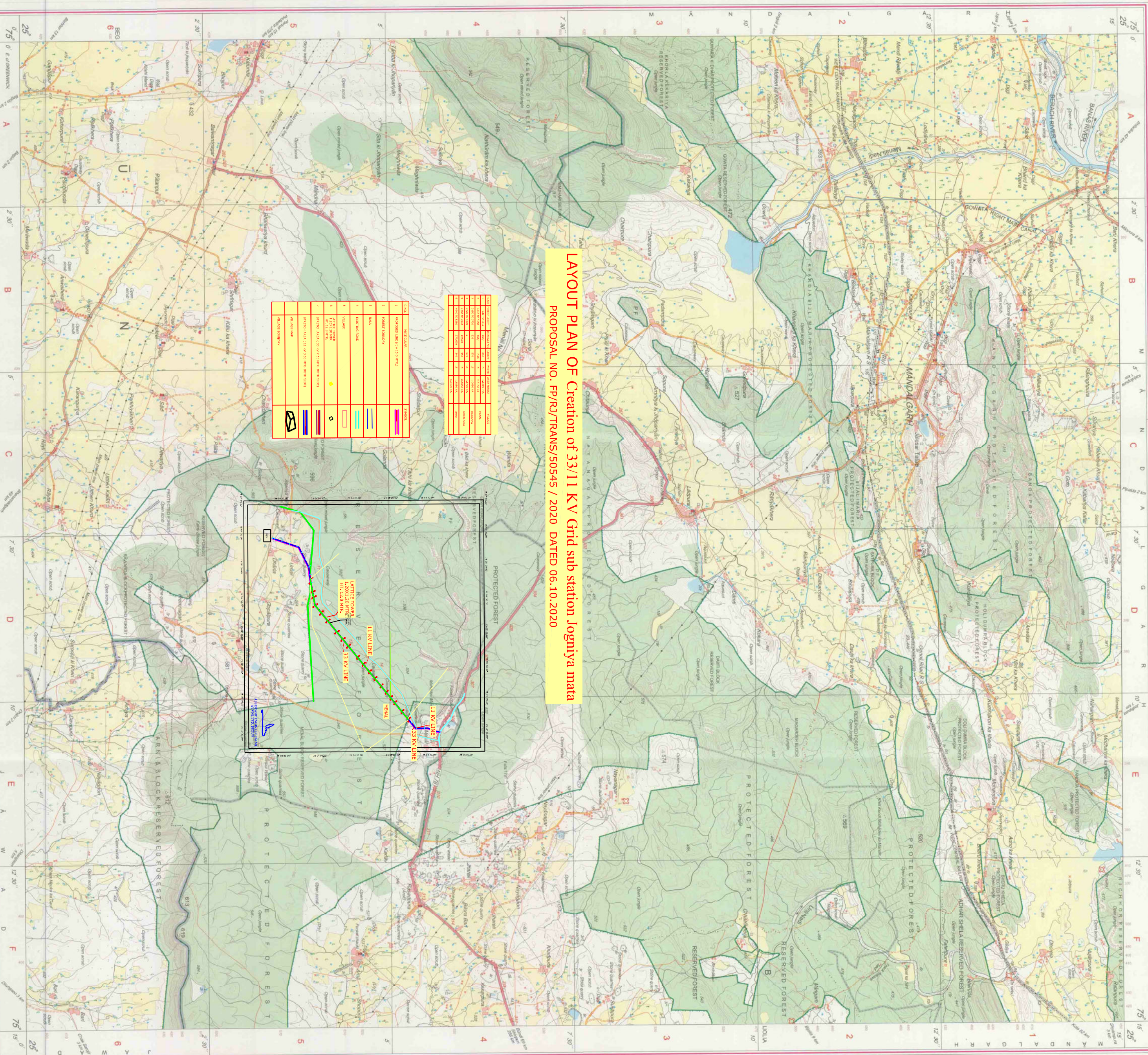
