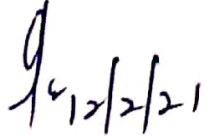

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No-11-9/98-FC(pt.) dated 3rd August, 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 on the forest land proposed to be diverted for non-forest purpose, read with MOEF's letter dated 5th February 2013 wherein MOEF issued certain relaxation in respect of linear project, it is certified that **4.10 hectare** of forest land proposed to be diverted in favour of **Himachal Pradesh Public Works Department** GoHP for the **Construction of Link road from Chuieugalli to Sagoti road Km 0/0 to 6/00** in Chamba District falls within the jurisdiction of **Sagoti** villages in Tehsil Salooni, District Chamba.

It is further certified that: -

- a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **4.10 hectare** of forest land proposed for diversion. A copy of records of all consultation and meetings of the Forest Rights Committee, Gram Sabha, Sub Division Level Committee and the District Level Committee are enclosed as annexure-I to annexure-IV.
- b) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gram Sabhas have given their consent to it. (Not applicable)
- c) The proposal does not involve recognized rights of Primitive Tribal Groups and pre-agricultural communities.
