DEMAND NOTICE

It is submitted that the PCCF,AP, Guntur reference 1st cited, communicated stage- I (in-principle) approval under section -2 of Forest Conservation Act-1980 for diversion of 051 Ha of Florest land in compt.no.127 Kondaveedu Extn - I R F in Guntur division & District for laying of 132KV DC / SC Transmission line from 132 / 33 KV Sub station Vengalayapalem (Nallapadu) to 25 KV R T S S, Nallapadu for extending supply to Indian Railways in favour of Executive Engineer, Construction Divsion, AP, TRANSCO, Guntur subject to fillfulment of certain conditions which was communicated to the user agency for compliance vide ref.3rd cited.

In the reference 4th cited the user agency has deposited an amount of Rs.56.00 Lakhs towards Compensation for the infrastructure existing in the premises of Nallapadu Central Nursery and Nagaravanam vide condition No.5 and for Rs.3.1926 Lakhs towards NPV for the diverted forest land vide condition No.3. Thus the total amount deposited by the user agency stands Rs.59.1926 lakhs and the rest of the conditions are yet to be fulfilled by the user agency.

Further it is submitted that the usera agency has given an under taking stating that they shall abide by the conditions laid down by the Govt. of AP vide G.O.Rt.No.127 E FST&T(Sec-II), dept. Dated.22.06.2017. A copy of the same is appended herewith.

In the mean while in the reference 5th cited, the Executive Engineer, Construction Division, A P, TRASCO, Guntur addressed the Divisional Forest Officer, Guntur and stated that as per the field conditions 25 Nos of trees are be felled for execution of the said line works in the subject land. Further, it was also stated that a joint inspection was conducted on 30.08.2017 and identified the list of trees to be felled and assured that they would arrange the payment for felling charges on raising the demand.

Accordingly, a scheme proposals comprising raising of 250 No of trees (25 X 10 = 250 Nos) or 0.25 Ha including loss of tree growth and extraction charges has been prepared with a financial out lay of Rs 5,55,786/- (Rupees Five Lakh Fiftyfive Thousand and Seven Hundred and Eightysix only) has been arrived at and submitted to the Chief Conservator of Forests, Guntur Circle Guntur for approval. In turn the Chief Conservator of Forests, Guntur Circle Guntur submitted the same to the Principal Chief Conservator of Forests, A P Guntur.

In the reference 7th cited, the Principal Chief Conservator of Forests, A P Guntur accorded permission for felling of trees in the proposed alignment of submect linear project as per the Government of India Guidelines as contemplated vide F No. 11- 306/2014 – F C (Pt) Dated: 28.08.2015 duly collecting the charges as applicable from the User Agency as detailed below.

a) Raising of plantaion - Rs 1,00,000
b) Loss of Tree Growth - Rs 4,21,786
c) Extraction Charges - Rs 34,000

Total Rs 5,55,786/-

In view of the above, the Executive Engineer, Construction Division, A P, TRANSCO, Guntur is requested to deposit an amount of Rs 5,55,786/- (Rupees Five Lakh Fiftyfive Thousand and Seven Hundred and Eightysix only) in the accounts mentioned below immediately for further course of action. Apart from this the user agency also requested to comply all the conditions imposed by the Govrnment for further course of action.
