- For laying Iron Ore slurry Pipeline, Project within Non- ROW(Linear Project) (non-forest land-12.0000 Ha.)
- Private Railway siding with unloading facilities, water Intake station and water Reservoir. (non-forest land-17.0000 Ha.)
- Approach road from NH-520 to proposed RMHS and Connecting Road from RMHS to Iron Ore Grinding Plants and Water Pipeline(linear Project).(non-forest land-6.0000 Ha.)

Now S.P.Singh ,Director, JSW Utkal Steel Ltd. has intimated that during submission of their requirement they had not considered Hal/sabik issues and submitted request accordingly. Also due to technological optimization of the project and further verification of land type (Hal/Sabik), configuration of projects has slightly changed as mentioned below. Therefore he has requested to amend the projects details for the said land as there is no change in the total extent of non-forest land.

> 1. Private Railway siding and unloading facilities (16.539 Ha.)

2. Approach road from NH-20 to proposed RMHS and Connecting Road from RMHS to Grinding unit, and Water Pipeline slime pipeline(linear Projects)(10.754 Ha.)

3. Water intake well and grinding unit including RMHS

(22.707 Ha.)

In view of the above.I am to say that the commitment made vide this office letter No.1551 /Rev.Dt.1.10.18 has been amended as per their request.Further, in pursuance of guideline issued vide letter F.No.11-306/2014-FC dated 07.10.2014 of MOEF &CC, Govt. of India, I am to say that the above schedule of non-forest land identified earlier will be transferred and mutated in favour of the State Forest &Environment Department for creation of CA against the three projects indicated above on payment of premium of the land by the project proponent immediately on receipt of stage-I approval under the FC Act for diversion of forest land required by the project proponent.

You are also requested to file requisition before the Tahasildar, Banspal for sanction of alienation in favour of the State Forest & Environment Department after receipt of receipt os Stage-I approval under F.C.Act.
