In his letter 6th read above, the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad has requested the Government for diversion of forest land to an extent of **0.4971 ha** in **Manugur forest division** under Bhadradi-Kothagudem District, for laying of Optical Fiber Cable along the road and within the existing Right of Way, in favour of M/s Reliance Jio Infocomm Limited.

2. Government, after careful examination of the proposal of the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad, and in the light of the guidelines issued by the Government of India, Ministry of Environment & Forests, in the letters 1st to 5th read above, hereby accord permission to the Principal Chief Conservator of Forests (HoFF), Telagana State, Hyderabad, for diversion of forest land to an extent of **0.4971 ha** in **Manugur forest division** under Bhadradi-Kothagudem District, for laying of Optical Fiber Cable along the road and within the existing Right of Way, in favour of M/s Reliance Jio Infocomm Limited, subject to fulfillment of the following parameters / conditions:-

- i) The proposed work should be carried out without felling of trees and no cutting of branches is allowed;
- ii) The maximum size of the trench is 2.00 mtrs depth and 1.00 mtr width. laid out along the road and within the existing right of way;
- iii) The User Agency to make good the land after use/ maintenance;
- iv) The User Agency to make good any loss to forests / environment;
- v) The User Agency should take permission for carrying out any maintenance; and,
- vi) The User Agency should pay compensation for the felled & damaged trees, if any.
