Sub: Diversion of 0.70 ha of forest land in sy No 225 of Halaki village, Murgod Hobali, Savadatti Taluk, Belagavi District for improvement Road from Hulikeri Tanda to Halaki under Gandhi patha Gram Patha (NGNRY-4) in favour of Executive Engineer, Karnataka Rural Road Development Agency (KRRDA) project Division, Karnataka Rural Road Development proposal No.FP/KA/ROAD/29864/ 2017.

In accordance with the Government of India Ministry of Environment and Climate Change Regional office (South Zone), Bengaluru referred at (1) and as per the instructions of the Chief conservator of forests, Bangaluru cited at reference (2) above, it is here by brought to your notice that the Government of Karnataka have accorded its approval subject to following.

- 1) The legal status of the forest land shall remain unchanged and it shall continue to be as forest land.
- 2) The boundary of the forest land to be diverted be demarcated by concrete pillars of 2m hight on ground at the project cost as per directions of concerned Divisional Forest Officer before Stage-II Approval.
- The Net Present Value (NPV) of forest land diverted under this proposal as per orders dated: 28-3-2008 and 9-5-2008 of the Hon'ble Supreme Court of India. It means the user agency has pay Rs. 3,06,600/-(At class-IV-Open forest rate @4.38.000/- per ha for 0.70 ha). The user agency has to draw a Demand Draft in favour of SB A/c.No.SB01025213-CAF Karnatakar Corporation Bank CGO Complex, Lodhi Road-110003 (RTGS/IFSC No.CORP0000371) or in SB A/C. No.344902010105421-KARNATAKA CAMPA, Union Bank of India, sunder Nagar, New Delhi-110003 (RTGS/IFSC NO. UBIN0534498) and submit the same to this office.
- 4) All the funds received from the user agency under the project shall be transferd/deposited to CAMPA fund only through (https:parivesh.nic.in/)
- Avenue planting shall be taken up by User agency along the road on either special preference to fruit trees at the project cost. The user agency shall furnish an undertaking to this effect.
- 6) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.

7) The forest area shall be used for purpose for which it is granted. The total forest area utilized for the project shall not exceed 0.7 ha.

8) The forest area proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Government of India.

9) The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/)

10) Any other condition that the Ministry of Environment and Climate Change may stipulate from time to time in the interest of Conservation, protection and development of Forest Wildlife.

Hence, you are hereby requested to comply the above conditions and make necessary deposits to CAMPA Adhoc Account through RTGS immediately. And submit the compliance of the same for taking further action in this regarding.
