

Justification and Detailed note of the Project

The Govt. Ministry of Tourism under Swadesh Darshan division has sanctioned an amount of Rs.8440.49 lakhs under Integrated Development of Mulugu-Laknavaram-Medaram-Tadwai-Damaravi-Mallur Bogotha Waterfalls as Tribal circuit in Telangana. One of the project component is Laknavaram Tourism was sanctioned for Rs. 2765.54 lakhs.

The present proposal is submitted for Construction of Reception centre with approach road and Construction of Parallel Bund/Road at Laknavaram Tourism place in Mulugu District. for an extent of 0.6403 Ha, the details are as follows:

1. The Laknavaram Lake is major tourist attraction in the Mulugu district. The tourists are visiting to Laknavaram by way of four wheelers, bikes and heavy vehicles. Heavy traffic on Saturdays and Sundays and other public holidays and the traffic is jammed for about two to three hours, which is causing inconvenience to the visiting tourists of Laknavaram and sometimes it leads to accidents. The existing road having width of 5 meters only. The existing road is insufficient for two way traffic and the existing bund is having deep gorge on the downstream of the road (bund) and water on the right side of the road (upstream of the bund). The forest land is upstream side of bund also up to 15 feet from the toe of existing bund. The TSTDC has proposed alternate road parallel to the existing bund inside the tank bed to avoid the traffic and smooth running of tourist's movement during the weekdays and other general and public holidays. As there is no other way to avoid traffic jams and road accidents. Hence, the M/s.TSTDC has proposed for construction of Parallel Bund/Road at Laknavaram Tourism place.
2. It is also proposed to construct reception centre with amenities like Rest Room, Cloak Room, Hospitality with approach road from parking area. These are very much essential to the tourists who visit these place.
3. Hence the proposals are being submitted for an area of 0.6403 Ha under F(C)Act, 1980.
