

- (c) The each concerned Gram sabha (s) has certified that all formalities /processes under the FRA have been carried out and they have given their consent to proposed division and compensation and ameliorative measures, if any having understood the purposed and details of proposed division, A copy of certificate issued by the Gram Panchyat, Aapchand, Chandrapura, Belaimafi, Chandrpura, Chapra in Sagar tehsils. is enclosed as Annexure-I to annexure VI
- (d) The discussion and decision of such proposal had taken place only when there was a quorum of minimum 50% of member of Grama sabha present;
- (e) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and Gram Sabhas have given their consent to it;

The right of primitive Tribal Ground and Pre Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) of the FRA.
