In compliance to the above condition, it is stated that a Site specific wildlife conservation Plan for Daitari Iron ore Mines and Daitari Extension area has been approved at a financial outlay of ₹1798.70 lakh in this office memo No.9569 dt 02.12.2013. The project area in the instant case involving 106.016 ha is located in Rebana RF between Daitari Iron Ore mines (1018.3085 ha) and Daitari Extension area (249.968 ha). The mitigative measures as per the approved Site specific wildlife conservation Plan will also meet the need of wildlife conservation of the present area.




