For compliance of **condition No.xxi** imposed in the aforesaid Stage-I order, ~~the~~ RCCF, Angul circle has approved the scheme for undertaking Gap Planting and SMC work to restock and rejuvenate the degraded open forest at a cost of **Rs.64,06,921/-**.
