With reference to the subject 2<sup>nd</sup> cited, the stage-I approval have been accorded for diversion of 2.688 Ha of forest land from Koheda to Arepally via Dharmasagarpally from 4/3 to 7 km in Siddipet District in favour of Panchayathraj Division Siddipet.

Further it is to inform that vide reference 4<sup>th</sup> cited, the demand notice for payment of net present value (NPV), cost of raising & maintenance of avenue plantations and construction of boundary pillars have been submitted to the Principal Chief Conservator of Forests, Telangana, Hyderabad with a request to approve the following amounts.

1	Net Present Value @626000/-per ha for 2.688 ha.	1682688.00
2	Boundary pillars for 280 @ 600/- each intermediate RCC pillars for 4' height with 6x6 c/s on either side of the road an interval of 20 mtrs.	168000.00
3	Boundary pillars for 18 @7500/- each intermediate RCC pillars for 4' height with 1.2 mts base on either side of the road at an interval of 200 mtrs entry exit points.	135000.00
4	Cost of 3 kms raising & maintenance of avenue plantations (to be implemented by the U/A).	784000.00

The same have been approve by the Principal Chief Conservator of Forests, Telangana, Hyderabad vide reference 5<sup>th</sup> cited.

Therefore the Engineer in Chief PR, Hyderabad is requested to upload the demand notice at [www.forestclearance.nic.in](http://www.forestclearance.nic.in) and inform the same to the nodal officer FCA for accepting the demand online in the forest clearance portal.

After acceptance by the nodal officer the U/A shall generate e-challan for Rs.1682688/- in words (Sixteen lakhs eighty two thousands six hundred and eighty eight

through online mode only in the Telangana state compensatory Afforestation for management and planning authority (CAMP) same bank account maintained in the corporation bank CGO complex, Lodhi Road, New Delhi.

The U/A has to deposit an amount of **Rs.303000/-** (in words Rupees Three Lakhs and Three thousand) only into the PD account of District Forest Officer Siddipet bearing No. 656067228 in Indian Bank Siddipet Branch, IFSC code- IDIB000S270.

The U/A shall undertake Afforestation on either side of the road for an amount of **Rs.784000/-** for implementation by the U/A. The U/A shall submit an undertaking to this effect in the compliance report.

further the Engineer in Chief PR, Hyderabad is also requested to intimate the details of payments made and submit seven sets of compliance report on all the conditions stipulated in stage-I approval along with all the necessary documents, certificates, undertakings etc for onward submission to the competent authority for issue of final approval.

Transfer of Forest land proposed for diversion to the U/A shall not be affected prior to the issue of final approval.
