ORDER:

Vide reference 1st read above, the Superintendent of Police, Bhadradri Kothagudem has requested to arrange suitable Non Forest land admeasuring Ac.5.00 gts for Compensatory Afforestation in lieu of Forest lands proposed for establishment of CRPF Camp in Ac.5.00 gts at Chennapuram Village of Charla Mandal of Bhadradri Kothagudem District, as the Forest Divisional Officer, Bhadrachalam has sought the details of CA area which is equivalent to proposed diverted Forest land.

Vide reference 2nd read above, a letter has been addressed to the Revenue Divisional Officer, Kothagudem to identify suitable Non Forest land in lieu of diversion of above Forest land.

Accordingly, vide reference 3rd read above, the Tahsildar, Dammapeta has submitted non Forest land availability report stating that an extent of Ac. 5.00 gts land is available in Sy.No. 349/1 of Mandalapally Village of Dammapeta Mandal and is suitable for compensatory Afforestation. Further, he reported that the present proposed Non Forest land is abutting to the earlier proposed CA Land in lieu of Forest land taken for construction of BT Road in RF area of Dammapeta & Mulakalapally Mandals.

Further, vide reference 4th read above, the District Forest Officer, Bhadradri Kothagudem has submitted feasibility report stating that the Forest Divisional Officer, Paloncha has inspected the above said location on 01.07.2021 and noticed that, the identified area is admeasuring Ac. 5.00 gts/1.99 Ha situated in Sy.No.349/1, Mandalapally Village of Dammapeta

Mandal adjacent to 12.14 Ha patch (the present proposed Non-Forest land is abutting to the earlier proposed CA land in lieu of Forest land taken up construction of BT road in RF area of Dammapeta and Mulakalapally Mandals). The land is a hillock covered with tree growth and it is suitable for taking as Compensatory Afforestation land in lieu of diversion of 1.99 Ha of Forest land in favour of Superintendent of Police; Bhadradri Kothagudem for establishment of CRPF Camp at Chennapuram village of Charla Mandal, Charla Range of Bhadrachalam Division of Bhadradri Kothagudem District.

Thus, the District Forest Officer, Bhadradri Kothagudem has requested the District Collector, Bhadradri Kothagudem to arrange to hand over the above said Non Forest land to Forest Department and to mutate the same in favour of Forest Department to further process of the proposals under Forest (Conservation) Act, 1980 and for notification as Reserved Forest Land under Forest Act and also instruct the User Agency to submit DGPS survey details of CA land to Principal Chief Conservator of Forests (HoFF), T.S. Hyderabad for authentication.

Hence the Tahsildar, Dammapeta is hereby directed to mutate the CA land Ac. 5.00 gts in Sy.No. 349/1 of Mandalapally Village of Dammapeta Mandal in lieu of Forest land Ac.5.00 gts at Chennapuram Village of Charla Mandal, in favour of Forest Department in online and manual Revenue records and handover the above mentioned CA lands to the Forest Range Officer concerned under cover of Panchanama immediately and send the copies of Revenue records and panchanama copies to the undersigned.
