The Commissioner & Director State Project Director,SSA,TS,HYDERABAD As Accorded Administrative Sanction for Construction of New Buildings in Newly Formed Mandal in the Nirmal District With an Estimated Cost Of Rupees 350 Lakhs For KGBV Building (Residential School For Girls Strength Of 200 Students) At Village Ananthapet Mndl Nirmal (R) Dist Nirmal.

The proposed Residential School from KG to PG is being Constructed for Education of 2000 girls.
