As per the letter cited under reference (1), The Government of India has accorded in principal (Stage -1) approval under Section '2' of Forest (Conservation) Act 1980 for diversion of 1.5383 ha. of "deemed forest" land with private ownership in Sy.No 146/57 A1E1 of Neriya Village in Belthangady Taluk, D.K. District, for establishing 24 MW Mini Hydel Scheme in favour of M/s. SLV Power Private Limited, Mangalore. Further, Nodal officer and Additional Principal Chief Conservator of Forests (Forest Conservation), Bangalore, vide letter cited under

reference (2), as per the conditions stipulated in stage -1 approval, has directed to issue demand note to the User Agency within 7 days and instructed to furnish the compliance report without any loss of time.


Hence, you are hereby instructed to pay the following sum of money.

Further, you are also instructed to submit the undertaking about the following conditions which were mentioned below and submit the compliance to all the conditions mentioned in the Stage -1 approval to this office as early as possible.

1. Additional payment of NPV of the diverted deemed forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from User Agency.
2. The weir should be kept open for drinking of water by wild animals.
3. Any other condition that the Additional Principal Chief Conservator of Forests (Central), Regional Office, Bangalore may impose from time to time for protection of, improvement of flora and fauna in the forest area and public convenience shall also be applicable.
