Resettlement and Rehabilitation Plan

The plan for rehabilitation & resettlement of affected families has been worked out as per Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013. It is proposed to develop 01 R&R site for affected families of Morand Dam and 01 R&R site for Ganjal Dam.

In Morand Dam 04 villages of Hoshangabad district will come under the submergence i.e Morghat, Lahi, Samardha & Kamtha, hence 01 R & R site has been proposed for those villages. The proposed R & R site is located at Lokhartalai village in Hoshangabad District.

In Morand Dam land pertaining to 02 more villages viz. Jhiriyadoh and Jamnagari villages of Betul district will also come under submergence; the houses are not affected hence Rehabilitation does not arise and only land compensation is necessary.

In Ganjal Dam 02 forest villages of Harda district will come under the submergence viz. Bothi & Kayari Ghat. In Kayari Ghat the submergence is almost within the river bank, in case of Bothi both the land & properties will come under the submergence, hence 01 R&R site is selected for the rehabilitation of the affected families in village Singanpur in district Harda.

Total number of families getting affected in the proposed Ganjal & Morand Dam submergence is 172 and 472 respectively.

In Morand Dam out of 472 Project Affected Family (PAF), 440 PAF's are coming under Hoshangabad District and 32 PAF's are coming under Betul District.

Rehabilitation policy also suggests that every adult son and every adult unmarried daughter has also to be treated as separate family. Accordingly each Oustee of family is allotted a residential plot at the proposed R&R site. All civic amenities as per the rehabilitation policy shall be developed at these sites for the benefit of the oustees families, barring such facilities as already exist in the nearby host villages provided. It can cater the needs of the oustees families without adversely affecting usage thereof by the host villages. The same are mentioned below:

- (a) Roads within the resettled villages and all weather road link to the nearest pucca road. Passages and easement rights for all the resettled families be adequately arranged.
- (b) Proper drainage as well as sanitation plans executed before physical resettlement.
- (c) One or More assured sources of safe drinking water for each family as per the norms prescribed by the Government of India.
- (d) Provision of Drinking water for Cattle.
- (e) Grazing Land as per proportion acceptable in the State.
- (f) A reasonable number of fair Price Shops.
- (g) Panchayat Ghars, as appropriate.
- (h) Village level Post Office, as appropriate, with facility if needed.
- (i) Appropriate seed-cum-fertilizer storage facility if needed
- (j) Efforts must be made to provide basic irrigation facilities to the agricultural land

allocated to the resettled families if not form the irrigation project , then by developing a cooperative or under some Government Scheme or special assistance.

- (k) All new villages established for resettlement of the displaced persons shall be provided with suitable transport facility which must include public transport facilities through local bus services with the nearby growth centers/urban localities.
- (I) Burial or cremation ground, depending on the caste communities at the site and their practices.
- (m) Facilities for sanitation, including individual toilet points.
- (n) Individual single electric connections (or connection through non-conventional sources of energy like solar energy), for each household and for public lighting.
- (o) Anganwadi's providing child and mother supplemental nutritional services.
- (p) School as per the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (35 of 2009)
- (q) Sub-health centre within two kilometers range.
- (r) Primary Health Centre as prescribed by the Government of India.
- (s) Playground for children.
- (t) One community centre for every hundred families.
- (u) Places of worship and chaupal /tree platform for every fifty families for community assembly, of numbers and dimensions consonant with the affected area.
- (v) Separate land must be earmarked for traditional tribal institutions.
- (w) The forest dweller families must be provided, where possible with their forest rights on non-timber forest produce and common property resources, if available close to the new place of settlement and, in case any such family can continue their access or entry to such forest or common property in the area close to the place of eviction, they must continue to enjoy their earlier rights to the aforesaid sources of livelihood.
- (x) Appropriate security arrangements must be provided for the settlement, if needed.
- (y) Veterinary service centre as per norms.

Cost provision of Rs. 2895 Lakhs & Rs.1712 Lakhs have been made towards Infrastructural Amenities at proposed Resettlement sites for PAF's of Morand and Ganjal respectively.

Rehabilitation benefits as per policy:

- a) Rs. 340.50 Lakhs & Rs.158.25 Lakhs have been provided in R&R Plan for Provision of housing units in case of displacement in Morand and Ganjal respectively.
- b) Provisions of Rs. 1350.00 Lakhs & Rs.370.00 Lakhs have been provided in R&R plan for allotment of agriculture land or cultivable waste land in Morand and Ganjal respectively.
- c) Subsistence grant for displaced families for a period of one year, the provision of Rs. 163.44 Lakhs & Rs. 59.00 Lakhs have been made in Morand and Ganjal respectively.
- d) Rs. 115.00 Lakhs & Rs.18.75 Lakhs have been provided for financial assistance for construction of cattle shed/petty shops in Morand and Ganjal respectively.
- e) Rs. 236.00 Lakhs & Rs.68 Lakhs have been provided for Transportation cost for the oustee in Morand and Ganjal respectively.
- f) Financial assistance of Rs. 1.50 Lakhs & Rs.0.25 Lakh for rural artisans, small traces and self employed people for construction of shops or working shads in Morand and Ganjal respectively.

- g) Rs. 3115.00 Lakhs & Rs.1235.00 Lakhs have been provided for PAFs those are not made available agriculture land or employment one time financial grant equivalent to 5 Lakh rupees in Morand and Ganjal respectively.
- h) Rs. 311.50 Lakhs & Rs.123.50 Lakhs have been provided for each affected family one time resettlement allowance of Rs. 50,000/- in Morand and Ganjal respectively.
- Affected families fishing Rights will be as prescribed by Govt of Madhya Pradesh in both the reservoir.
- j) The stamp duty and others fees payable for registration of house allotted to the affected families shall be borne by the requiring body, the provision of Rs. 944.00 Lakhs & Rs.344.00 Lakhs have been made in Morand and Ganjal respectively.
- k) Where the affected families belong to S.C. & S.T. are relocated outside of the distt. Then they shall be paid 25% extra benefits along with one time grant of Rs. 50,000, provision of Rs. 200 Lakhs & Rs. 50 Lakhs have been made. in Morand and Ganjal respectively.

Total rehabilitation benefits are of Rs. 6777.00 Lakhs & Rs. 2427 Lakhs for the oustee along with the PAF's belongs to S.C. & S.T. Families.

Detailed cost estimates have been prepared for land acquisition and rehabilitation including infrastructural facilities for oustees. These are based on property survey carried out. The abstract is as under

In addition to above as per the suggestions of Expert Appraisal Committee (EAC) members of GoI, MoEF &CC prepared a permanent livelihood for employment of PAF members & made a cost provision of Rs. 15 Cr implementing the livelihood plan.

The R&R plans of both the dams have been reviewed in detail at **Gol**, **Ministry of Tribal Affairs (MoTA)** and issued the clearance for the same vide their Memo. F.No.4/10/2016-M & J, Gol, MoTA, Shastri Bhawan, New Delhi dated: 14-03-2017.
